#### **Previous minutes**

#### Matters arising

2. There were no matters arising.

#### **Business Programme**

- 3. The Bureau agreed a programme of business for the weeks commencing 29 November and 6 December 2021.
- 4. - 5. The Bureau discussed remote participation in Chamber business, and noted the preference where possible and safe for Ministers to participate in person in debates to enable the making and taking of interventions. - 6. The Bureau also discussed the point of order raised by Stephen Kerr on 18 November regarding the content of answers to written questions. The Minister indicated he was happy to look at this issue.

# Referral and timetabling of Bills at Stage 1

- 7. The Bureau agreed to recommend to the Parliament that the Covid-19 Recovery Committee be designated as the lead Committee for the Coronavirus (Discretionary Compensation for Self-isolation) (Scotland) Bill.
- 8. The Bureau also agreed to lodge a motion suspending or varying various Standing Orders to enable the Bill to proceed to an expedited timetable.
