Previous minutes

1. The minutes of 15 March 2022 were agreed.

Business Programme

- 2. The Bureau agreed a revised programme of business for the week commencing 21 March 2022, and programmes of business for the weeks commencing 28 March and 18 April 2022.
- The Bureau agreed that Members Business on Tuesday 29 March would be S6M-03278: Sarah Boyack: Commonwealth Day 2022 on 14 March 2022 on Wednesday 30 March would be S6M-03472: Marie McNair: Ovarian Cancer Awareness Month, and on Thursday 31 March would be S6M-03259: Kaukab Stewart: Impacts of Benefit Sanctions
- 4. The Presiding Officer noted that Jamie Greene would be invited to make some remarks at the start of business following the death of David Hill. Stephen Kerr noted his appreciation for the support from the Presiding Officer, Chief Executive and First Minister to the Scottish Conservative and Unionist Party following David's death.
- 5. Stephen Kerr requested ministerial statements on the following issues:
- drugs deaths
- the Covid vaccine certification scheme
- the Climate Change report
- pothole repairs
- The European Charter of Local Self-Government (Incorporation) (Scotland) Bill and the United Nations Convention on the Rights of the Child (Scotland) Bill.
- 6. Stephen Kerr confirmed he would send these requests in writing to the Minister for further consideration and a response.

Approval of SSIs

- 7. The Bureau noted that motions to approve the following SSIs would be taken in the Chamber during the week commencing Monday 21 March with the exact date confirmed later by correspondence:
 - Coronavirus Act 2020 (Alteration of Expiry Date) (Scotland) Regulations 2022 (SSI 2022/40)
 - Health Protection (Coronavirus, Restrictions) (Directions by Local Authorities) (Scotland) Amendment Regulations 2022 (SSI 2022/Draft)
 - Coronavirus (Scotland) Acts (Amendment of Expiry Dates) Regulations 2022 (SSI 2022/Draft)
