Previous minutes

1. The minutes of 3 May 2022 were agreed.

Business Programme

- The Bureau agreed a revised programme of business for week commencing 9 May and programmes of business for the weeks commencing 16 and 23 May 2022.
- 3. 5. The Bureau agreed to recommend a Stage 2 deadline of Tuesday 31 May 2022 for the Non-Domestic Rates (Coronavirus) (Scotland) Bill.

Coronavirus (Recovery and Reform) (Scotland) Bill at Stage 2

6. The Bureau agreed, subject to the Bill passing Stage 1 on Thursday 12 May, to recommend, under Rule 9.7.1(b), that stage 2 consideration of the Coronavirus (Recovery and Reform) (Scotland) Bill be divided between the Covid-19 Recovery Committee and the Criminal Justice Committee.

Referral of draft proposal for Member's Bill

7. The Bureau agreed to refer the draft proposal on the Schools (Residential Outdoor Education) (Scotland) Bill to the Education, Children and Young People Committee.

Approval of SSIs

 - The Rehabilitation of Offenders Act 1974 (Exclusions and Exceptions) (Homes for Ukraine Sponsorship Scheme) (Scotland) Amendment Order 2022 (SSI 2022/draft)
