### Previous minutes

1. The minutes of 17 May 2022 were agreed.

## **Business Programme**

- 2. The Bureau agreed a revised programme of business for week commencing 23 May 2022 and agreed programmes of business for the weeks commencing 30 May and 6 June 2022.
- 3. Stephen Kerr requested a Ministerial Statement in w/c May from the Deputy First Minister on the issue of ferries, supported by Neil Bibby, which the Minister did not agree to schedule.
- 4. Neil Bibby requested a Ministerial Statements on ScotRail timetabling issues and on educational attainment.
- 5. Stephen Kerr also requested Ministerial Statements on the following issues:
  - Project Neptune
  - Census update
  - Update on justice system IT error
  - Result of the consultation on the Lord Advocate's role
  - Prestwick Airport
  - Future of rural bus services
  - Scottish Information Commissioner's report on legal advice connected to a second independence referendum
  - Scottish Information Commissioner's report on the Scottish Government's handling of FOI requests

The Minister confirmed he would respond in writing to these requests.
