Previous minutes

1. The minutes of 19 and 20 December 2022 were agreed. The Bureau noted that a minute of the discussions which took place during the Stage 3 of the Gender Recognition Reform Bill would also be produced.

Business Programme

- 2. The Bureau considered a revised programme of business for the week commencing 9 January and a programme of business for the weeks commencing 16 and 23 January 2023.
- 3. The Bureau agreed that the Finance and Public Administration Committee Debate on Committee pre-Budget reports, scheduled for 26 January, be extended by 30 minutes in order to allow Members of the Committee to speak.
- 4. Neil Bibby and Alexander Burnett requested that the debate on People's Right to Choose Respecting Scotland's Democratic Mandate be removed from the Revised Business Programme and the time re-allocated to a debate on the NHS instead. The Bureau did not agree to this request.
- 5. Neil Bibby and Alexander Burnett reserved their parties' position on the revised business programme.

Approval of SSIs

- 6. The Bureau noted that motions to approve the following would be lodged—
- Winter Heating Assistance (Low Income) (Scotland) Regulations 2023 (SSI 2022/Draft)
- Bankruptcy and Debt Arrangement Scheme (Miscellaneous Amendment) (Scotland) Regulations 2023 (SSI 2022/Draft)
- 7. Alexander Burnett and Neil Bibby reserved their parties' position on the Winter Heating Assistance (Low Income) (Scotland) Regulations.

Timetabling of a Bill at Stage 1

8. The Bureau agreed to recommend to the Parliament that consideration of the Charities (Regulation and Administration) (Scotland) Bill at Stage 1 be completed by 28 April 2023.
