### Agenda item 1 – Previous minutes and matters arising

1. The Bureau agreed the minutes of its meeting on 3 June.

## Agenda item 2 – Business Programme

2. The Bureau agreed a revised programme of business for the week beginning 9 June and a programme of business for the weeks beginning 16 and 23 June.
3. Business Managers noted that Members' Business in the week beginning 16 June would be—

  - that the Standards, Procedures and Public Appointments Committee be designated as the lead committee in consideration of the Freedom of Information Reform (Scotland) Bill at Stage 1.
