4. Motions submitted for Members' Business are shown below—

**S6M-06325:** Evelyn Tweed: Ferrier Family Raises £30,280.90 for Cardiomyopathy UK - That the Parliament congratulates the Ferrier family from Doune and Deanston on their incredible efforts raising £30,280.90 for Cardiomyopathy UK, which will assist the charity in providing support advice and

nursing support; understands that the Ferrier family began fundraising following the death of Callum Ferrier on 12 February 2008, and that Callum, a 6-foot-tall rugby player, aged 16, went to bed complaining of a headache and was found the next day by his dad, having died from cardiomyopathy, something the family had never heard of; further understands that, since Callum's death, the family has focused on fundraising for Cardiomyopathy UK through arranging ceilidhs, treks of the Sahara, Machu Picchu and the Great Wall of China, coffee mornings, Tough Mudder competitions, running the Stirling and London marathons and the Great British 10k Run, kids treasure hunts, a skydive, funeral collections, online collections, a Gargunnock songster concert and supper, selling wristbands, raffles, a fashion show and dinner, barn dance and many more fundraising efforts; understands that the family has had assistance from a number of individuals and businesses to help in their fundraising including Craig Johnstone, Craig Mair of Skelpit Lug Ceilidh Band, St. Modans High School, Souters, Gargunnock Songsters choir, Graeme Morgan of Natural Choice, Doune, Woodlane of Doune and McLaren Rugby Club; notes that cardiomyopathy is a disease of the heart muscle, with "cardio" meaning heart, "myo" muscle and "pathy" disease, and that it is not a single condition, but a group of conditions that affect the structure of the heart and reduce its ability to pump blood around the body, and understands that it affects around 1 in 250 people in the UK.

S6M-06299: Pam Gosal: Recognising the International Day for the Elimination of Violence Against Women - That the Parliament recognises the International Day for the Elimination of Violence Against Women on 25 November, and the 16 Days of Activism following this, which run from 25 November to 10 December 2022, Human Rights Day; recognises that the 2022 global theme is "UNITE! Activism to end violence against women and girls"; notes the view that this is an opportunity to come together with the global women's movement to call for an end to gender-based violence; further notes reports that the COVID-19 pandemic has intensified all forms of violence against women and girls (VAWG); believes that VAWG remains the most pervasive human rights violation worldwide; understands that it affects more than an estimated 1 in 3 women; notes that it is estimated that on average a woman or girl is killed by someone in her own family every 11 minutes across the globe; welcomes that, during the pandemic, UN Women, women's rights organisations and others acted with urgency to secure policy changes aimed at eradicating VAWG; believes that there is growing evidence that VAWG is preventable; commends the hard work of organisations and individuals that aim to eradicate any and all forms of violence against women, and notes the view that Parliament should do everything in its power to contribute to the work to stop violence against women and girls.

S6M-06274: Douglas Lumsden: Channel 4's 40th Anniversary - That the Parliament congratulates Channel 4 on its 40th anniversary; considers that Channel 4 is publicly-owned and commercially-funded, meaning that it can deliver a valuable public service at zero cost to the taxpayer; welcomes what it sees as the important and growing contribution Channel 4 makes to the Scottish production sector, working closely with Screen Scotland; understands that their new Glasgow hub now has the biggest commissioning department by commissioning hours based in Scotland; congratulates Channel 4 for, it understands, surpassing its target to spend half of its

original content budget outside of the London area; understands that over 400 roles, encompassing 55% of spend and 66% of hours, are now based outside of the London area; believes that Channel 4 has spent around £220 million on Scottish productions over the last 15 years, with £23.5 million of Scottish spend in 2021; appreciates what it sees as the benefit of Channel 4's skills and training schemes, such as 4Skills, which focuses on social mobility and bringing new, underrepresented voices into the industry; understands that 4Skills will reach 15,000 young people a year from 2022 onwards, including many in Scotland; believes that Channel 4 is a great success story for the UK, and wishes the teams at Channel 4 all the best for many more successful and creative years ahead.

S6M-06232: Paul McLennan: UNITE! 16 Days of Activism against Gender-based Violence - That the Parliament recognises the international campaign, 16 Days of Activism Against Gender-Based Violence, beginning on 25 November 2022, which is International Day Against Violence Against Women, and ending on 10 December 2022, which is Human Rights Day; understands that the theme for this year's campaign is "UNITE! Activism to end violence against women and girls", which calls for global actions to increase awareness, galvanise advocacy efforts, and share knowledge and innovations; believes that, while pervasive, gender-based violence is not inevitable, and it can and must be prevented; notes the view that stopping this violence starts with adopting comprehensive and inclusive approaches that tackle the root causes, transform harmful social norms, and empower women and girls, and further notes repeated calls for individual men, including those in the East Lothian constituency, to look inward at their own behaviour and to make the necessary changes that it considers can lead to the societal change required to bring an end to violence against women and girls in Scotland and beyond.

S6M-06230: Alexander Burnett: Improving Outcomes for People with Neurological Conditions - Conditions, That the Parliament welcomes the publication of the Together for the One in Six report from the Neurological Alliance of Scotland; understands that the report draws its conclusions and recommendations from a survey of over 800 people living in Scotland with a neurological condition; notes that the report found there were delays in the diagnosis of and treatment for neurological conditions; considers that these findings are the result of pre-existing structural problems, exacerbated by the impact of the COVID-19 pandemic; further considers that the Scottish Government's plan to implement the Strategic Framework for Action on Neurological Care and Support has been delayed, and is unlikely to have achieved its objectives by its end point in 2025; highlights the view that services for children and young people with neurological conditions should be included in future strategic work; understands that the report concluded that there was a lack of data around the wider prevalence of neurological conditions, and notes the view that the Scottish Government must now address this and begin work to develop a comprehensive plan that ensures Scotland, including Aberdeenshire West, has the workforce and resources to support people with neurological conditions now and deliver better outcomes for them in the future.

S6M-06229: Paul McLennan: The Economic Impact of Scotland's Renewable Energy Sector – 2022 Update - That the Parliament welcomes the publication of

The Economic Impact of Scotland's Renewable Energy Sector – 2022 Update, by Scottish Renewables and the Fraser of Allander Institute, which it understands provides the latest economic output and job figures for Scotland's renewables energy industry; understands that the report demonstrates that Scotland's renewable energy industry and its supply chain supported more than 27,000 full time equivalent jobs, and that onshore wind supported the most employment across Scotland's economy from the renewable energy sector, with 10,120 full time equivalent roles, followed by offshore wind with 6,735 full-time equivalent roles, and hydropower with 4,395 full-time equivalent roles; highlights the report's findings that Scotland's renewable energy industry generated £5.6 billion of output in 2020; considers that the report found onshore wind had the largest estimated economic output, generating nearly £2.5 billion, with offshore wind and hydropower both supporting more than £1.1 billion output, and welcomes what it sees as the strength of Scotland's renewable energy industry and the energy security, economic, environmental and social benefits that it brings to communities across Scotland, including in East Lothian.

## S6M-06216: Katy Clark: Higher Education Workers' Dispute -

That the Parliament notes the recent industrial action by university staff following the closure of the UNISON higher education pay ballot on 19 August 2022; further notes that staff at the University of Glasgow, Edinburgh Napier University and Robert Gordon University represented by UNISON, which include cleaners, administrators and library, catering and security workers, most recently took strike action on 3 and 4 October; understands that the Universities and Colleges Employers Association's (UCEA) final offer of 3%, or 7.2% for the lowest paid workers, is sub-inflationary as the current CPI rate is 9.9% and the current RPI rate is 12.3%; considers that UCEA's offer has been imposed on university staff despite being subject to a live dispute with the trade unions, and that such impositions also occurred in 2021 and 2020; understands that the trade unions, University and College Union, Educational Institute of Scotland-University Lecturers' Association and Unite, are at varying stages of consulting or balloting their members for action in the same dispute; believes that industrial relations in the sector have deteriorated to an unacceptable level; notes the view that the staff do incredible work and deserve to be recognised fairly and paid properly: further notes the belief that the Scottish Government must urge universities and UCEA to take meaningful steps to negotiate a fair resolution to these disputes, and notes the calls on universities and UCEA to return to the negotiating table in the interests of workers and students.

**S6M-06215:** Bill Kidd: Co-op, SAMH, Mind and Inspire's Together Through Tough Times Report - That the Parliament welcomes the publication of the SAMH, Mind, Inspire and Co-op report, Together Through Tough Times; notes that, during the COVID-19 pandemic, researchers surveyed 4,500 people and conducted qualitative research with two demographic groups from four regions of the UK, including Yoker in the Glasgow Anniesland constituency; further notes that this research investigated communities experiencing higher than expected wellbeing outcomes, particularly in areas with high deprivation, to look at how communities can strengthen an individual's mental wellbeing and what makes a community resilient;

recognises the findings that three protective factors build resilience, which are talking about mental wellbeing, the existence of community hubs where people can access informal support, and the development of strong and collaborative community and voluntary sectors, where people can build lasting friendships; supports the Co-op's fundraising efforts, which reached £8 million from its colleagues, customers and members, and which will fund SAMH, Mind and Inspire to deliver mental health support in 50 local communities, reaching an estimated 10,000 people, and commends the work of all charities and local groups across Scotland that are helping strengthen community resilience.

S6M-04821: Clare Adamson: Complex Regional Pain Syndrome (CRPS) Awareness Month 2022 - That the Parliament marks Complex Regional Pain Syndrome (CRPS) Awareness Month, which is held every November; understands that CRPS is a chronic disorder, mostly affecting the limbs, which is characterised by severe pain, pathological changes of bones, joints and skin, swelling, temperature and colour changes and motor dysfunction; further understands that the condition and awareness of its impact is poorly understood both in Scotland and globally; notes that the first Monday of November marks Colour the World Orange Day, which encourages businesses, town halls and landmarks to change their lights to orange in support of people with CRPS; commends the volunteers and organisers at CRPS UK and Burning Nights CRPS Support for their efforts to raise awareness of the condition; further commends the work of CRPS UK and Burning Nights CRPS Support, which, it understands, are registered charities with the shared goals of raising CRPS-symptom awareness, providing what it sees as invaluable support to people with the condition, and advocating for more research development into its effects; notes that the Burning Nights CRPS Support eighth annual CRPS conference will be held on 26 November 2022 at the Novotel Edinburgh Park, aimed at patients living with complex regional pain syndrome, and their families and friends, to help give them support and to help their understanding of the condition, treatment options and more, and wishes all participants in the Awareness Month and those in the wider CRPS community the very best.

S6M-06180: Sarah Boyack: World Homeless Day - That the Parliament welcomes World Homeless Day, on 10 October 2022, and considers that dignified and adequate housing is a human right; recognises reports that, in 2021, there were over 28,000 homeless households in Scotland and that a third of those included children; believes that the current cost of living crisis poses a greater pressure on households and an increasing demand on support services and expertise than ever before; appreciates the work that the homeless charity, Cyrenians, carries out all-year-round to tackle both the causes and consequences of homelessness; notes that Cyrenians works with and listens to the voices of people with lived experience to enable the work that it undertakes to be as progressive as possible; supports efforts by Cyrenians and other charities working in Scotland's local communities to provide essential support for those facing crisis as well as carrying out work to prevent people from reaching crisis; understands that Cyrenians hopes that, on this World Homeless Day, people of all backgrounds and communities consider supporting work to eliminate homelessness in their local community, and notes calls for

everyone to support efforts to invest in homelessness prevention work, towards a day where this event becomes "World Homeless Prevention Day", placing homelessness as a thing of the past.

S6M-06145: Graham Simpson: Free Rail Travel for Blind and Partially Sighted People and Companions - That the Parliament notes that there is no national entitlement to free rail travel for companions under the National (Scotland) Concessionary Travel for Blind Persons card; understands that this is in contrast to the provision afforded to bus travel; is concerned that cost was named by more disabled people than non-disabled people as a reason not to use the train in the 2021 Scottish Household Survey; believes that a national rail concession policy for companions would improve safety, access to employment and social connections for the estimated 180,000 people living with sight loss in Scotland, including in the Central Scotland region, and notes the calls on the Scottish Government to work with local authorities to establish a national policy.

S6M-06140: Jamie Greene: Reinstating the CalMac Season Travel Pass for Isle of Cumbrae Residents - That the Parliament recognises what it considers the importance of the CalMac monthly season pass for travel to Isle of Cumbrae residents and commuters; further recognises what it sees as the unique challenges that Cumbrae residents face living as part of an island community; regrets reports that CalMac and Transport Scotland have removed the ability to use the pass until further notice; understands that the cost of travel to Cumbrae for residents with the season pass will almost double and place additional pressure on their finances during the global cost of living crisis; notes the calls for the reinstatement of the season travel pass by Transport Scotland as a matter of urgency, and further notes the calls on the Scottish Government, Transport Scotland, CalMac, North Ayrshire Council and locally elected representatives to work together towards the goal of bringing back the season travel pass as soon as is feasibly possible.

S6M-06112: Sue Webber: Scottish Government Commissioned Review of ME Services and Future Action - That the Parliament notes that the Scottish Government commissioned and welcomed an independently-produced stakeholder review of the NICE guideline on Myalgic Encephalomyelitis/Chronic Fatigue Syndrome (ME/CFS), published on 5 July 2022; further notes that the review states that myalgic encephalomyelitis (ME) or chronic fatigue syndrome (CFS) is a complex chronic medical condition affecting an estimated 250,000 people in the UK and that around 20,000 people in Scotland are living with the condition, including in the Lothian region; highlights the four key symptoms characteristic of the condition, which are debilitating fatigue that is worsened by activity, post-exertional malaise (PEM)/symptom exacerbation, unrefreshing sleep and/or sleep disturbance, and cognitive dysfunction, and which affect multiple physiological systems and can fluctuate from mild to very severe in individuals and across the population affected; understands that the review recommends consideration be given to identifying the most effective approaches to improving GP knowledge, confidence and understanding of ME/CFS through an appropriate education programme, and further understands that the review recommends that pilot services should be funded in a

selection of NHS boards to test the development of specialist services with patient involvement and third sector collaboration embedded in the design.

S6M-06107: Rachael Hamilton: Supporting Mental Health in Rural Communities - That the Parliament welcomes Scottish Interfaith Week, taking place from 13 to 20 November 2022, organised by Interfaith Scotland; understands that this year's theme is storytelling; considers that this is Scotland's foremost interfaith festival, and as such has the unique opportunity to explore how faith and belief impact communities and offer resilience, connection and joy; further considers that storytelling enables barriers to be broken down, stereotypes to be challenged and important conversations to be started, and notes the hope that members of faith and belief communities all over Scotland can participate in this year's Scottish Interfaith Week and that everyone, including residents of Glasgow Shettleston, considers attending their nearest event.

**S6M-06010:** John Mason: Scottish Interfaith Week - That the Parliament welcomes Scottish Interfaith Week, taking place from 13 to 20 November 2022, organised by Interfaith Scotland; understands that this year's theme is storytelling; considers that this is Scotland's foremost interfaith festival, and as such has the unique opportunity to explore how faith and belief impact communities and offer resilience, connection and joy; further considers that storytelling enables barriers to be broken down, stereotypes to be challenged and important conversations to be started, and notes the hope that members of faith and belief communities all over Scotland can participate in this year's Scottish Interfaith Week and that everyone, including residents of Glasgow Shettleston, considers attending their nearest event.

## S6M-05911: Emma Roddick: Mental Health Stigma in the Workplace -

That the Parliament is concerned by what it sees as continued stigmatisation of mental health issues and those who experience them; considers that, while wider understanding of depression and anxiety is progressing, organisations such as the Royal College of Psychiatrists have noted a pervasive stigma relating to personality, dissociative, and psychosis-related disorders; understands that this stigma is particularly concentrated in the world of work, meaning that people with psychiatric conditions are less likely to be employed or remain so; notes efforts such as SeeMe Scotland's See Me in Work scheme, which aim to support employers to tackle mental health discrimination; understands that a survey by SeeMe was explored in a recent report, Mental Health – Exploring the Current Landscape, published by Centred, a mental health charity based in the Highlands of Scotland, which showed around half of people believe someone would not disclose a mental illness at work for fear of adverse effects on their employment; considers that this report contains valuable research around stigma, rural mental health, and the overall situation in Scotland; further notes the belief that this demonstrates that more work needs to be done by employers, public health agencies and government to tackle mental health stigma, and notes the calls for these issues to be addressed in the new Scottish Government Mental Health Strategy.

**S6M-05903: Stuart McMillan: National Eye Health Week 2022 –** That the Parliament notes National Eye Health Week, which runs from 19 to 25 September

2022 and provides an opportunity to promote the importance of maintaining good eye health, and to raise awareness of the services and support available to people on the sight loss pathway across Scotland; considers that everyone in Scotland should undertake a free eye health check at least every two years to pick up as early as possible any changes before they affect vision, and allow effective treatment regardless of where they live or what background they come from; understands that 50% of sight loss is avoidable; notes the work across the third sector, optometry, the NHS and Scottish Government in developing the provisions of the sight loss pathway; further notes the support for continued focus on improving the communication and shifting the balance of care between available services, and increasing the use of the best available technology in patients' sight loss journey; notes the support for an end-to-end sight loss pathway providing patients with the best care possible; recognises the work of Optometry Scotland and the visual impairment sector in supporting the work of the NHS and social services on the sight loss pathway; commends the efforts of Optometry Scotland and RNIB Scotland in promoting National Eye Health Week, and notes the calls for people living in Greenock and Invercive, and across Scotland, to book their free eye health check if they have not done so in the last two years.

S6M-05887: Stuart McMillan: Recovery Month 2022 - That the Parliament commends the efforts of third and public sector organisations across Inverclyde during Recovery Month 2022; understands that to mark International Overdose Awareness Day on 31 August 2022, Moving On Inverclyde, the Salvation Army in Greenock, Inverclyde Recovery Hub, CVS Inverclyde and Jericho House took part in Inverclyde Council's alcohol and drugs team's Recovery Opens Doors initiative, where they were open to the public and other stakeholders, highlighting the work they do to help those living with addiction within the community; further understands that the organisations have come together to offer a range of events during September for Recovery Month, including a remembrance vigil to remember those who have been lost to alcohol and drug misuse, a recovery football tournament, involving teams from Jericho House, The Haven and Inverclyde Recovery Hub, a stigma and kindness workshop, and tea in the park, offering live music, face painting and food for free; believes that partnership working in Inverclyde is having a positive impact on efforts to reduce alcohol and drug-related deaths in the community, with, it understands, the number of drugs deaths reducing from 33 to 16 last year; considers that this figure still represents 16 lives lost, with the lives of families and friends being devastated, and notes the view that efforts to prevent drugs deaths must continue at pace so that the number of people who succumb to addiction continues to fall; grieves the loss of all those who have lost their lives through addiction, and notes the view that Parliament should do all it can to prevent drug and alcohol related deaths and to help ensure people have access to the right treatment at the right time.

**S6M-05880:** Bob Doris: How Will We Survive: Steps to Preventing Destitution in the Asylum System – That the Parliament notes the impact of the cost of living crisis on people seeking asylum in the Glasgow Maryhill and Springburn constituency, and across Scotland; further notes the research published by the British Red Cross and Refugee Survival Trust, How Will We Survive? Steps to

preventing destitution in the asylum system; understands that the report was written by peer researchers with lived experience of the asylum system, through the Destitute Asylum Seeker Service; further understands that it outlines seven overarching recommendations, covering both the Home Office and Scottish Government, including that the Scottish Government should pilot a peer support system to ensure new arrivals through the asylum system can access support, guidance and friendship from people who have shared experiences of navigating the asylum system, that people with no recourse to public funds should have access to adequate support and increased access to health services, including mental health support, and that the Home Office should automatically grant people the right to work if they have been waiting for longer than six months for a decision on their initial asylum claim, or following the submission of further evidence, and that such a right should not be restricted to jobs on the shortage occupation list, and notes the view in the report that the Home Office should also offer an initial grant to asylum seekers to help them set up life in the UK, which it considers would lessen the likelihood of destitution.

## S6M-05853: Clare Adamson: Pancreatic Cancer Awareness Month 2022 -

That the Parliament marks Pancreatic Cancer Awareness Month, which takes place in November, and World Pancreatic Cancer Day, which takes place on 17 November 2022; understands that pancreatic cancer is the deadliest common cancer in Scotland and the UK, with more than half of people diagnosed dying within three months; further understands that survival rates have barely changed in 50 years; considers that data on the experience of patients with this disease is incredibly scarce and poor, leading to concerns of patients' voices being lost in the system; believes that support and information for patients with pancreatic cancer is often neither readily available nor forthcoming; applauds the work of the range of pancreatic cancer charities that do provide information and support for patients and their families; notes the view that more needs to be done to ensure that all patients get immediate and easy access to such support as soon as they are diagnosed, given that, it understands, currently only 12% of people diagnosed with pancreatic cancer in Scotland are using such support channels; commends all the charities and activist organisations and their dedicated supporters for their tireless efforts to raise awareness of pancreatic cancer, and wishes everyone involved with Pancreatic Cancer Awareness Month every success in their endeavours.

**S6M-05810:** Jenni Minto: A83 Rest and Be Thankful – That the Parliament welcomes the Scottish Government's announcement of £25 million which aims to secure a long-term solution to the Rest and Be Thankful pass on the A83 in Argyll and Bute; notes its intention to appoint Atkins WSP Joint Venture to progress design and development work for the route through Glen Croe; welcomes the intention that the proposals for the medium-term solution will be made by the end of 2022, with an announcement on the preferred route option for the long-term by Spring 2023; recognises what it considers as the important work of the Rest and Be Thankful Campaign Group in emphasising the needs of the business communities across Argyll and Bute in seeking to find the right solution; further recognises the work that the Scottish Government and the A83 Task Force have done, and continue to do,

which aims to ensure a safe and lasting solution is found for the road, and considers it is a necessity to have a reliable route into Argyll and Bute for the area's communities, businesses and visitors.

S6M-05762: Rhoda Grant: Specialist Neurological Nursing Posts - That the Parliament is concerned by the reported decision of NHS Western Isles to remove the posts of Epilepsy and MS specialist nurse; understands that concerns have been expressed about the long-term future of the Parkinson's specialist nurse post; notes reports that the NHS board intends to replace these posts with a more generalist advanced neurology nursing post; further notes reports that the NHS board proposes to increase the scope of the nursing post to cover more neurological conditions; considers that this would represent a real terms cut to the service with fewer nursing hours dedicated to supporting more people; notes the view that in a cost of living crisis it is imperative to ensure patients have access to as much care and treatment locally as possible; recognises that there is no on-island neurologists or specialist support and that people with neurological conditions have to travel to NHS Greater Glasgow and Clyde for face-to-face appointments; understands that NHS Greater Glasgow and Clyde does not intend to increase its support to the islands in the wake of this reported cut to specialist nursing provision; recognises what it sees as the importance of the specialist nursing posts in this context and based on the testimony from people living with epilepsy, MS and Parkinson's on the Islands; understands that this decision was reportedly taken without any consultation with local neurological communities or the national charities that initially helped to fund the posts; further understands that local and national groups have expressed concern that such a cut to specialist nursing provision has the potential to put the safety of those in the local community affected by neurological conditions in jeopardy, and notes the calls from local groups, including Neuro Hebrides, Parkinson's Western Isles and national stakeholders, including Epilepsy Scotland, MS Society Scotland and Parkinson's UK Scotland, for NHS Western Isles to work collaboratively with them and people affected by neurological conditions in the Western Isles to deliver a comprehensive service that meets the needs of all stakeholders.

S6M-05725: Maurice Golden: Sustainable Fashion Week 2022 – That the Parliament marks Sustainable Fashion Week 2022, which will run from 16 to 25 September 2022, and the opportunity it offers to recognise what it sees as the long-standing efforts of businesses, charities and community groups throughout Scotland to promote sustainable textiles and fashion; notes reports of the disproportionately high environmental impact of discarded textiles in Scotland compared with other materials; further notes the reported potential global impacts of fast fashion that is imported to Scotland through extended supply chains, including poor working conditions and negative outcomes for the natural environment; believes that a circular economic model offers the best opportunity to reduce those impacts through increased reuse of clothing and new business models of leasing and renting, whilst developing sustainable manufacturing using native fibres; further believes that such a model would encourage rural wealth creation through enhanced opportunities for fibre producers, such as wool farmers, and the network of makers using traditional skills, such as weaving and knitting, to support high quality manufacturing, and notes

the calls to encourage stakeholders to build on existing best practice to establish Scotland as a global leader in sustainable textiles.

## S6M-05709: Christine Grahame: Brexit's Impact on Inflation -

That the Parliament notes with concern the reported impact of Brexit on inflation and the cost of living across Midlothian South, Tweeddale and Lauderdale and elsewhere in Scotland; further notes that research by the UK in a Changing Europe think tank reportedly revealed that Brexit has increased food prices by 6%; notes reports that sterling has lost 10% of its value, leaving households poor by increasing import costs and inflation while lowering wage growth; is aware of research published by the London School of Economics and Resolution Foundation stating that Brexit has reduced how open and competitive Britain is, leading to, it believes, reduced productivity and wages over the next decade; recognises that the Office for Budget Responsibility reportedly says that Brexit will have the long-term effect of cutting UK GDP by 4%; understands that the Financial Times agreed that such a decline will mean £100 billion of lost output and £40 billion less revenue for the Treasury each year; is concerned by reports that the UK has now fallen behind all other G7 countries in the pace of its recovery from the COVID-19 pandemic, with, it understands, exports down significantly, and notes the view that Scotland will prosper more by regaining its independence and re-joining the EU than by remaining in the UK.

S6M-05701: Clare Adamson: Mark Scott Leadership for Life Award - That the Parliament congratulates the Mark Scott Leadership for Life Award, which celebrates its 25th anniversary, on, it understands, positively impacting the lives of over 32,500 people; acknowledges the journey of the Mark Scott Award, which was founded in 1998, after the tragic death of Mark Scott in a reportedly unprovoked sectarian attack in 1995, and has sought to challenge the divisions in communities across Central Scotland by bringing together young people from different backgrounds to work together for the benefit of others; understands that it initially empowered 12 young people to develop skills and qualities to help them into further education and employment through outdoor learning and community-based projects, and has since awarded over 3,500 young people from 67 schools, across 11 local authorities within the Central Belt of Scotland, the Mark Scott Leadership for Life Award; further understands that 580 community projects have been delivered within local communities, with 156 young people participating during 2022-23; welcomes the Scottish Government's reported commitment to funding the award, with £1.15 million since 2012 and a further £75,000 pledged for 2022-23; understands that the Outward Bound Trust has partnered and supported the Mark Scott Foundation from the very beginning, and is now fully responsible for developing and growing the award, and wishes all associated with the Mark Scott Leadership for Life Award every continued success.

**S6M-05696: Clare Adamson: Scottish Games Week –** That the Parliament marks the first ever Scottish Games Week, which will take place from 24 to 28 October 2022; understands that Scottish Games Week, organised by the Scottish Games Network, with the Scottish Government's Tech Ecosystem Review (STER) fund, will focus on videogames and position the sector as a key part of Scotland's digital

future; notes that this event will showcase what it sees as Scotland's pioneering and diverse games ecosystem and act as a catalyst for a more connected and collaborative sector across Scotland, the UK and internationally; understands that Scottish Games Week will bring together game developers, publishers and educators, as well as the broader games tech ecosystem and streamers, and that all of the events will be hybrid, offering the opportunity to attend in-person or join an online stream, to put games created in Scotland in front of a global audience; considers that Scotland has played a pioneering role in the evolution of the games sector since the late 1980s and continues to produce some of the world's most popular games, including Grand Theft Auto and Minecraft; understands that Scottish games development companies invest £141 million in salaries and overheads, employ 6,400 people, contribute £129 million in tax revenue and are worth around £350 million to the Scottish economy; welcomes the first ever Scottish Games Awards, recognising, rewarding and highlighting what it sees as the incredible creativity, technical expertise and business acumen that the pioneering and rapidly evolving games sector in Scotland offers, including in the Motherwell and Wishaw constituency, and wishes everyone involved in Scottish Games Week the very best with the initiative going forward.

S6M-05667: Brian Whittle: Scottish Commonwealth Success - That the Parliament recognises the success of Scottish athletes at the 2022 Commonwealth Games; commends the accomplishments of every Scottish participant at the 2022 Commonwealth Games, which, it understands, is the highest medal-scoring games for Scotland since the 2014 Glasgow Games with 51 medals; notes that Scottish Athletics has the largest medal total in over 40 years, including Eilish McColgan's record-breaking 10,000m gold, Laura Muir's back-to-back gold in the 1500m and bronze in the 800m, Jake Wightman's 1500m bronze victory, and the women's 4x400m team's bronze medal; further notes that medals in swimming from Toni Shaw, the 4x200m men's relay team, Stephen Clegg, Ross Murdoch, Duncan Scott, Katie Shanahan, and James Heatly and Grace Reid's gold medal in diving, gives Scotland the highest tally in aquatics from any Commonwealth Games; understands that Greg Lobban and Rory Stewart's bronze in men's squash doubles is the first squash medal since 1998 and Louise Christie's silver in rhythmic gymnastics was the highest scoring performance for Scotland in history and the country's first medal in the sport in over 30 years; further understands that this was Scotland's most successful games for cycling, where 11 medals were secured, and para-bowls, where the country medalled in five of the six para-sports; congratulates all the Scottish athletes who participated in the Commonwealth Games; recognises the force for good that it believes sport can be in inspiring younger generations into sport, including in South Scotland, and enabling teaching through sport, and wishes them every success in the future.

**S6M-05568:** Stephanie Callaghan: 25 Years of the National Autistic Society Scotland: Creating a Society that Works for Autistic People – That the Parliament congratulates National Autistic Society (NAS) Scotland on the 25th Anniversary of its founding; understands that NAS provides a wide range of services and support to many of the 56,000 autistic people living in Scotland, including in the

Uddingston and Bellshill constituency, as well as to their families; welcomes both the variety and ongoing success of these services, which, it understands, include postdiagnostic support for children and young people, in-person and online social groups, one-to-one mentoring, supported living services and an education rights helpline; notes in particular what it sees as the success of NAS' training and employment support programme, Moving Forward+, which is funded via the Scottish Government's CashBack for Communities initiative, in preparing hundreds of autistic young people for meaningful employment; applauds the work of NAS volunteers across Scotland, whose work through local branches, it believes, is invaluable in communities; acknowledges what it sees as the many positive transformations that have been made across the country in the last 25 years to move towards a society that works for autistic people; recognises what it sees as the benefits of continued constructive engagement as the National Care Service develops; acknowledges what it sees as the importance of advocacy support to work to promote autistic people's rights across all services, including schools, further education, social security, housing, health and mental health services; welcomes the Scottish Government's commitment to presenting a Learning Disability, Autism, and Neurodiversity Bill to this Parliament, including the appointment of an associated Commissioner, and commends the National Autistic Society Scotland, Scottish Autism and ENABLE Scotland, for campaigning jointly on this important issue.

## S6M-05506: Craig Hoy: Protecting the Future of Scotland's Historic **Environment –** That the Parliament understands that stonemasonry is vitally important for the protection and preservation of Scotland's historic environment and tourism, and that it can be hugely beneficial to young people from deprived backgrounds to start their career; commends the Ridge Charity in Dunbar, which it understands currently supports some of East Lothian's most marginalised community members to gain access to modern apprenticeships in stonemasonry and joinery; regrets the reported impending loss of stonemasonry apprenticeships at Edinburgh College and the impact that this may have on young people in the south of Scotland; notes the calls on the Scottish Government, Skills Development Scotland, Historic Environment Scotland and South of Scotland Enterprise to consider what it sees as the potential serious repercussions for the Ridge Charity and for the apprenticeship opportunities for young people in the south east of Scotland, and further notes the calls for stakeholders, including the Scottish Government, to engage to identify a positive solution for an accessible location that could be used for young people from Berwickshire, Edinburgh and East Lothian to gain access to stonemasonry apprenticeships through a satellite provision of an existing college provider.

## S6M-05469: Siobhian Brown: Concern Regarding Youth Vaping –

That the Parliament notes reports of concern over vaping and a surge in young people using e-cigarettes; believes that vaping products are not for children, young people or non-smokers and are useful only as a potential route towards stopping smoking; understands from reports that there is potentially strong evidence that e-cigarettes, which are bright and colourful and can come in thousands of e-liquid flavours, can increase attractiveness to children and young people; further

understands that the long-term risks of vaping cannot yet be definitively confirmed by research studies; considers that these products are not harmless and are a risk to the long-term health of young people, and notes the view that it is important to highlight this for forthcoming generations in Ayr and across the country.

S6M-05413: Jeremy Balfour: Stories of Hope: Addiction Recovery – That the Parliament welcomes the new report published by the Evangelical Alliance and Serve Scotland, Stories of Hope: Addiction Recovery, highlighting what it sees as the extraordinary efforts that have been made by Christians in Scotland to assist and care for those in addiction and bringing to light the scope of Christian addiction recovery services across Scotland; notes the report's findings that over a quarter of Scotland's residential beds for addiction patients are offered by Christian groups; understands that over 2,300 individuals over the last decade have been directly supported to successfully recover from their addiction through services offered by Christian groups and churches across Scotland, including in the Lothian region, and notes the report's aim in encouraging greater joined-up partnership between the Scottish Government and Christian addiction recovery support charities to successfully tackle Scotland's drug deaths crisis.

**S6M-05292:** Stephen Kerr: A Potato With More Vitamin C Than a Lemon – That the Parliament believes that gene-editing technology is game-changing for food production; understands that there is a big difference between gene-modification and gene-editing; further understands that gene-editing makes small, specific changes to existing DNA, or removes a section altogether, speeding up a process that could occur through natural breeding; recognises that scientists at the James Hutton Institute in Dundee have reportedly predicted that gene-editing technology could result in potatoes with more vitamin C than lemons being grown, and considers that Scotland could be left behind England in food production due to Scottish legislation prohibiting the use of gene-editing in Scotland.

## S6M-05214: Pam Duncan-Glancy: Glasgow and Eurovision 2023 –

That the Parliament regrets that the Russian invasion means that Ukraine is unable to host the Eurovision song context in 2023, despite winning the competition; believes that, if the UK is to host Eurovision 2023 as the 2022 runner up, Glasgow would make the ideal host city; further believes that, as a city of culture, Glasgow can best embody the unity, strength, and resilience that it considers Ukraine has shown since the conflict began; believes that people truly do make Glasgow, and notes the view that Glasgow's communities need to be part of the planning process if the city is chosen as the host of Eurovision 2023, to ensure that the event meets its potential.

**S6M-03624:** Mark Griffin: Motherwell in Running to be New Home for Britain's Railways – That the Parliament welcomes Motherwell's entry into the national competition to become the new headquarters for Great British Railways (GBR), which, it understands, was submitted by North Lanarkshire Council; notes the UK Government's competition to find a home for the Great British Railways' headquarters, which must be outside of London; believes that Motherwell is perfectly placed to host the GBR headquarters; considers that the town is at the heart of

Scotland's rail network and has outstanding connectivity to Scotland and the rest of the UK; believes that the town has a highly-skilled workforce and one of the fastest-growing economies in the country, and that the location of the headquarters would attract further investment to the town, and understands that work is already well underway to considerably improve Motherwell railway station and transform it into a major UK transport interchange, which, it believes, will improve connectivity for all modes of transport including rail, bus, cycling, taxis and cars, as well as pedestrians.

S6M-03616: Martin Whitfield: UNCRC (Incorporation) (Scotland) Bill - One Year On -That Parliament notes that 16 March 2022 marks one year since the Scottish Parliament committed, it considers, to deliver a "revolution in children's rights" by unanimously passing the United Nations Convention on the Rights of the Child (Incorporation) (Scotland) Bill; believes that, by taking what it sees as a maximalist approach to incorporating children's rights into Scots law, Scotland is aiming to deliver a fundamental culture shift that, it considers, will transform the life chances and outcomes for children and young people, including in the South Scotland region; acknowledges that the Bill was passed after over 10 years of campaigning by children, young people and their families, and supported by children's organisations across Scotland; further acknowledges reports that the passage of the Bill was celebrated widely by children and young people through to teachers, social workers, the police, MSPs across all political parties and members of UN committees; accepts that it is over five months since The Supreme Court of the United Kingdom ruled that the Bill needs to be amended to bring it within the competence of the Scottish Parliament; welcomes the Deputy First Minister's commitment to address The Supreme Court judgment through the Scottish Parliament's reconsideration process; acknowledges the view that children and young people still do not know what timescale the Scottish Government is working to, or how long this process will take, and understands that, on the first anniversary of the Bill being passed, charities are urging MSPs to set out to children their continued commitment to the incorporation of the United Nations Convention on the Rights of the Child (UNCRC) into Scots law and to supporting reconsideration of the Bill that brings it within the Parliament's competence, and are requesting that the Scottish Government sets out a timescale for the reconsideration process so that children and young people know when UNCRC incorporation will be a reality in their lives.

S6M-03566: Joe FitzPatrick: Alcohol Management in Deep End Practices – That the Parliament welcomes the new report, Exploring the management of alcohol problems in Deep End practices in Scotland, which was funded by Scottish Health Action on Alcohol Problems (SHAAP) and carried out by researchers at the University of Dundee and University of Stirling, and which highlights the effectiveness of the Primary Care Alcohol Nurse Outreach Service (PCANOS) model in Deep End practices; understands that alcohol continues to cause a significant amount of harm in Scotland, including in Dundee; further understands that, in 2020, alcohol was directly responsible for 1,190 deaths in Scotland, with death rates 4.3 times higher among those living in the most deprived areas; highlights what it sees as the effectiveness of the PCANOS model, including its person-centred approach, one-to-one and flexible nature, and the fact that it enabled collaborative working

between practice staff; notes the calls for investment into alcohol services that reflects the need across the country; further notes that the report calls for more research to be carried out to establish an evidence base on the effectiveness of unique services such as PCANOS, in supporting people with moderate to severe alcohol problems who do not engage with alcohol services, and notes the calls for the Scottish Government to carefully consider the report's recommendation for the PCANOS model and other alcohol treatment services to be rolled out across Deep End practices, with long-term funding, to enable as many people as possible with alcohol problems, who have complex needs, to be supported.

S6M-03083: Alasdair Allan: Energy Bill Crisis for Island Communities - That the Parliament notes reports of growing concerns about what it sees as the energy bill crisis, including in Na h-Eileanan an Iar; understands that Ofgem's decision to raise the price cap will increase household energy bills by an average of 54%; considers that distribution levies unfairly penalise poorer people and those who live in rural areas; believes that the rise in energy costs from April will push many island households to breaking point; further believes that island residents are more vulnerable to what it sees as the current cost of living crisis due to existing higher living costs, including what it considers to be unfair energy levies, and to weather conditions, the lack of a mains gas option for most people, and low incomes in many areas; welcomes the Scottish Government's announcement of a £150 cost-of-living payment, which, together with funding for local authorities, will reportedly benefit 73% of households, and an additional £10 million to be targeted at people who are struggling to pay their fuel bills; considers that the power to make critical energy legislation is reserved to the UK Parliament; condemns the UK Government for, it believes, failing to step in further to prevent fuel poverty resulting from this situation: notes the calls for anyone who is struggling with their bills to contact Advice Direct Scotland for free practical advice; considers that the current devolution settlement prevents the Scottish Parliament from legislating directly on this issue, and notes the calls on the UK Government to do more to tackle what it believes to be the current fuel price crisis.
