Dear Conveners

Joint scrutiny of the draft Climate Change Plan

The Scottish Government laid the [draft Climate Change Plan \(CCP\)](#) on 6 November. The draft is laid for 120 days, therefore ending on 5 March next year.

I last wrote to you on [9 October 2025](#) outlining committee remits and how they may relate to scrutiny of the draft CCP. I said the NZET Committee could not practically scrutinise every major aspect of the draft in this period. Just as importantly, in many areas, the real in-depth knowledge and expertise has been built up in your committee in this session, so the NZET Committee would really welcome your engagement.

Now that we have the draft and that the clock is ticking down, I would be very grateful if Conveners could reply as soon as conveniently possible, outlining any scrutiny their committees intend to undertake.

I am especially grateful to committees who have already undertaken or committed to undertaking some work on the draft CCP. I do appreciate that for all of us this is a busy time, but I would very much welcome any support other committees can offer.

Timelines for committee scrutiny

It may be helpful to outline the NZET Committee's own agreed CCP scrutiny "backstops" now that these have been agreed: Committees are of course entitled to undertake scrutiny in the timescales that best suit them (within the 120 days) and that is a decision for them. However, the NZET Committee's role is to try to draw together the main threads of scrutiny, and consider whether the Plan as a whole "adds up" to meeting the recently set Carbon Budgets.

It would therefore be helpful to have all your main points in time for our final roundup evidence session with the Cabinet Secretary, or if that is not possible, in time for when we consider our draft report.

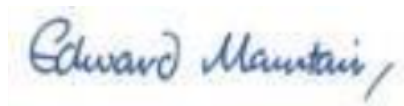
Indicative deadlines, would therefore be:
