- 1. Craig Hoy MSP welcomed participants to the meeting.
- 2. Purpose of the Group. It was agreed that the purpose of the Group should be to further the appreciation of good quality beer that is locally and independently brewed in Scotland. It also recognises the importance of pubs and licensed bars to community life, particularly those based in rural areas. The group will provide a forum to discuss policies that will impact on the beer and pub sector and affect beer drinkers and pub-goers across Scotland.
  - There are now 4,600 pubs and 120 breweries in Scotland. The brewing industry is an emerging sector in Scotland and there is currently no overlap with any other existing cross-party group.
  - The group provides an opportunity for MSPs and industry bodies to come together to discuss items related to the beer and pubs industry which have a direct impact on key government agendas such as tourism and the economy.
  - To inform MSPs of the issues and challenges facing pub owners and consumers and to highlight the impact pubs have on our economy and local communities particularly in rural areas.
  - The group will bring together key stakeholders in the pubs industry and aim to influence Government policy
  - Guest speakers from the industry may be invited to the Cross-Party Group to discuss how specific policy areas may affect them.

- Constituency specific issues may be raised, and there will be opportunity for MSPs to hear how they can support the beer and pubs sector in their patch.
- 3. Election of Officers. Craig Hoy MSP was elected a convener of the Group. Proposed - Graham Simpson MSP. Seconded - Colin Smyth MSP.

- 6. Working of the Group. Colin Smyth MSP highlighted the need for a clear action plan and tangible outputs from the Group. Rachael Hamilton MSP suggested that the Group should host a briefing on the progress of the Tied Pubs (Scotland) Bill.

Other issues of interest include the Deposit Return Scheme (DRS), recovery of the sector after the pandemic, business rates, legislation on alcohol advertising.

7. Programme and Activity Ideas. It was suggested that the Group could arrange a brewery visit, host an annual beer event, carry out an inquiry, initiate a guest ale programme in Parliament and arrange an award to identify the Scottish Pub of the Year.
