1. 28/02/23: Title: Restriction of Alcohol Advertising and Promotion in Scotland (Consultation).

The CPG looked at the Scottish Government's 'Consultation on Restricting Alcohol Advertising and Promotion' which sets out a range of potential proposals to reduce and restrict alcohol marketing including prohibiting alcohol advertising outdoors, phasing out alcohol sponsorship and reducing the promotion of alcohol in-store. 5 MSPs in attendance (Gordon MacDonald MSP, Daniel Johnson MSP, Murdo Fraser MSP, Sharon Dowey MSP, Douglas Lumsden MSP) and 17 non-MSPs.

- 2. 26/09/23: Title: Restricting promotions of food and drink high in fat, sugar, or salt. The Scottish Government is considering restricting promotions of food and drink high in fat, sugar, or salt. Ministers will take the next steps on proposing regulations soon. Our CPG discussed these issues and more.
  2 MSPs in attendance (John Mason MSP, Gordon Macdonald MSP) and 29 Non-MSP's.
- 3. AGM: 14/11/23: Title (2 topics): Illicit Trade and our annual report on the convenience sector in Scotland. SGF's 'Scottish Local Shop Report 2023'.

**Illicit trade -** alcohol, fireworks, toys (including electric and chargeable items), tobacco and vaping products were highlighted as being common illicit goods. HMRC discussed enforcement against illicit tobacco trade.

Local Shop Report - Issues such as Brexit, Covid and latterly the war in Ukraine have significantly destabilised the UK economy, alongside an ongoing period of societal change and this has resulted in challenging circumstances for retailers. The importance of the convenience sector for communities was highlighted also. 4 MSPs (Gordon Macdonald MSP, Daniel Johnson MSP, Murdo Fraser MSP, John Mason MSP) in attendance and 18 non-MSPs.

**Note:** A CPG was due to take place on Deposit Return Scheme on June 14<sup>th</sup>. However, this was cancelled due to uncertainties surrounding the scheme.
