## Agenda:

1) Opening remarks by the Chair Sarah Boyack, MSP

The Chair welcomed all those attending and covered some housekeeping points. The meeting had been arranged as a joint meeting between the Cross-Party Group on Malawi, of which Sarah is a vice-chair, and the CPG on International Development, which she chairs.

2) Remarks by Professor Sosten Chiotha, Chairperson of Kamuzu University of Health Sciences (KUHeS) Council

Prof Chiotha thanked the CPG and other stakeholders in Scotland for their warm welcome. He has recently been appointed to his role as Chairperson of the KUHeS Council.

3) Introduction of KUHeS delegation by Professor. Macpherson Mallewa, Vice Chancellor.

Prof Mallwella introduced the delegation.

4) Historical background presentation by Professor. Macpherson Mallewa, Vice Chancellor.

Prof Mallwella's presentation covered the historical background of KUHeS and its predecessor institutions and their relationship with Scotland, which stretches back beyond the current partnership arrangements; previous projects supported by the Scottish Government; the current Strategic Partnership Grant; and key achievements of the partnership.

5) Strategic Partnership Grant presentation by Dr Benjamin Kumwenda, Director of Student Affairs (Scottish Government Projects' Lead)

Dr Kumwenda spoke in more detail about the Scottish Government's Strategic Partnershup Grant, which aims to "enhance[e] KUHeS' capacity to effectively deliver its mandate through improved governance, academic excellence, and research capabilities, ultimately leading to better health outcomes in Malawi and Zambia." The grant is worth £500,000 per year for five years from 1st April 2024, and will continue to support MalDent, Governance, the Blantyre-Blantyre Lab and Monitoring Evaluation Research and Learning (MERL).
