20 May 2022 (AGM and general meeting)

Following the AGM, the CPG had three items for discussion. The first was the Annual Asthma Survey and Women with Asthma campaign, both by Asthma + Lung UK Scotland, the second was the Non-Communicable Diseases coalition led by David McColgan (British Heart Foundation Scotland) and Sheila Duffy (ASH Scotland), and the final item was the Respiratory Network, which is a group led by ALLIANCE Scotland to support the implementation of the Respiratory Care Action Plan.

There were 3 MSPs and 27 non-MSPs in attendance.

30 September 2022

This meeting looked at the impact of vaping on children and young people, with guest speaker Dr Jonathan Coutts from NHS Greater Glasgow & Clyde. Sheila Duffy from ASH Scotland also spoke about the recent vaping consultation and 2016 regulations. There was also a discussion on the NHS Scotland Climate Emergency and Sustainability Strategy, led by Garry McDonald, a respiratory pharmacist. An AOCB was raised by Action for Pulmonary Fibrosis on World Pulmonary Fibrosis Awareness Month.

There were 3 MSPs and 35 non-MSPs in attendance.

28 November 2022

The meeting discussed World COPD Day and a COPD report from Andrew Cumella of Asthma + Lung UK, followed by a presentation from Dr Edwin Van Beek on the UK National Screening Committee recommendation for lung screening. An AOCB was raised by Linda McLeod on smoking at hospitals.

There were 2 MSPs and 21 non-MSPs in attendance.

24 February 2023

The CPG heard from members of the International Coalition of Respiratory Nurses, President Andreja Šajnić, Dr Karen Marshall and Dr Miguel Padilha. Olivia Fulton also presented on the Severe Asthma Support Group. For AOCB, Gareth Brown provided a parliamentary update following a debate in the Scottish Parliament on youth vaping.

There were 2 MSPs and 32 non-MSPs in attendance.
