### **21 June 2021 (AGM and general meeting)**

In the June 2021 meeting, after the AGM took place, there was an update on the Respiratory Care Action Plan followed by the main presentations on Obstructive Sleep Apnoea by Dr Phyllis Murphie and Dr Will Anderson.

There were 3 MSPs and 17 non-MSPs in attendance.

### **27 September 2021**

In the September 2021 meeting, the main topic for discussion was asthma. The first asthma presentation was from the Asthma UK Centre for Applied Research and the second on the Precision – Sever Asthma Programme by Dr Tom Fardon.

There were 3 MSPs and 36 non-MSPs in attendance.

### **15 November 2021**

In the November 2021 meeting, the focus of the CPG was Chronic Obstructive Pulmonary Disease (COPD). Presentations were provided by Asthma UK and British Lung Foundation (now Asthma + Lung UK), a COPD patient and a representative from the Scottish Pulmonary Rehabilitation Action Group (SPRAG).

There were 2 MSPs and 32 non-MSPs in attendance.

### **28 January 2022**

In the January 2022 meeting, the themes and presentations of the meeting focussed on air pollution and the impact on lung health, and a survey of nurses' experiences during the pandemic. The speakers with Professor Jill Belch and Dr Nicola Roberts.

There were 2 MSPs and 30 non-MSPs in attendance.

### **20 May 2022 (AGM and general meeting)**

Following the AGM, the CPG had three items for discussion. The first was the Annual Asthma Survey and Women with Asthma campaign, both by Asthma + Lung UK Scotland, the second was the Non-Communicable Diseases coalition led by David McColgan (British Heart Foundation Scotland) and Sheila Duffy (Ash Scotland), and the final item was the Respiratory Network, which is a group led by ALLIANCE Scotland to support the implementation of the Respiratory Care Action Plan.

There were 3 MSPs and 27 non-MSPs in attendance.
