Item 5: Leadership Engagement Network

- SET discussed the scheduling and topics for discussion at future Leadership Engagement Network (LEN) meetings. SET also agreed that it was keen to hear from the LEN on topics they wished to discuss at future meetings.
- 6. SET agreed the agenda for the next round of LEN meetings, scheduled to take place in December 2025. SET was encouraged to note that the cochairs of the Colleague Engagement Forum (CEF) have indicated they would be happy to attend these meetings, in order to provide an update on the CEF's work to date.
- 7. SET agreed to issue communication, as well as a short briefing note to the LEN in advance of the December meetings. It also agreed the pattern of LEN meetings up to spring 2026.
