Scottish Parliament firsts

This Fact Sheet records the first occurrences of a wide range of Scottish Parliament events. Examples include first editions of Scottish Parliament publications and the first Scottish Parliament e-Petition. It does not aim to cover every permutation of first events or to be fully comprehensive in scope, and the wording used to describe 'Parliament firsts' may change over time. Where first instances of languages spoken in the Parliament are recorded, these instances may be a few words, or full sentences or speeches.

A 'Parliament first' might occur in Parliament generally, or in the Chamber or in a committee meeting specifically.

This Fact Sheet is arranged by date with the oldest date first and contains hyperlinks to more information where appropriate.

24 January 2019

First debate by the Finance and Constitution Committee to take place on [Committees' Pre-budget Scrutiny](#) – an aspect of the new budget scrutiny process based on recommendation 46 of the Budget Process Review Group, which stated that the Parliament should hold an annual debate allowing committees to discuss and debate their scrutiny and the general principles of the budget bill

5 March 2019

First time the Scottish Parliament and the National Assembly for Wales debated the same motion simultaneously: [the Scottish Parliament and the Welsh Assembly voted to pass identical motions calling for the planned Brexit date of 29 March 2019 to be put off](#)

6 March 2019

First grouping by the Presiding Officer of portfolio questions on the same subject matter so that these questions could be called consecutively. In this [Finance, Economy and Fair Work portfolio](#), questions 3 and 7 on a no deal Brexit were grouped together.

9 June 2019
