*S5M-00414 Edward Mountain: Donald Dewar Memorial Debate Competition—That the Parliament congratulates both Caitlin Sherrett and Finlay Allmond from the Nairn Academy debating team on winning the 2016 Donald Dewar Memorial Debate Competition; notes that the final was held in the Parliament under the watchful eye of the Deputy Presiding Officer, Linda Fabiani and that 128 teams, 256 pupils, from across Scotland entered the competition, which was run by the Law Society of Scotland; notes that the finalists also included the Royal High School (Edinburgh), Braes High School (Falkirk East) and St Maurice's High School (Cumbernauld), and considers that the standard of debate was excellent and a credit to all involved.

*S5M-00413 Neil Findlay: Time for Change at Sports Direct—That the Parliament is appalled by the reported "culture of fear" and "Victorian-era" work practices operated by Sports Direct, which is owned by Mike Ashley; is shocked by the revelations that practices at the company's locations are believed to have included incidences of non-payment of the minimum wage, the use of a "six strikes and you're out" mechanism, wage deductions for being late, prolonged security searches of staff, charges and cash withdrawal deductions for using pre-paid debit cards for the payment of wages, sexual harassment, the widespread use of agency labour and zero-hour contracts, unpaid training, significant health and safety issues, which include a case of an employee giving birth in a workplace toilet after having allegedly been refused permission to go home following reporting to managers that she was feeling ill, and overly-restrictive work breaks, including toilet breaks; understands that the company refuses to genuinely engage with Unite the Union, which represents many of the staff and the agency workers that it employs; applauds the union, and community and youth activists, on organising protests at several of the business's locations in Scotland to highlight and oppose what it sees as the exploitation of workers on zerohours contracts; believes that trade union-organised workplaces are healthier, safer and happier; further believes that Unite the Union should have a right of access to organise in and inspect Sports Direct's workplaces, and calls on Mr Ashley and the company to end the use of what it sees as unacceptable working practices, fully recognise Unite the Union as a representative of the workers and to engage with it to improve the wages, health and safety and terms and conditions at all Sports Direct's locations in Scotland and across the UK. R
