***S5M-00212 Keith Brown: Taking Scotland Forward – Scotland’s Economy, Short Term Resilience and Long Term Opportunities—**That the Parliament recognises the importance of a strong economy to underpin strong public services; recognises recent successes, such as Scotland securing more foreign development investment projects in 2015 than any other part of the UK outside London, but also acknowledges key challenges, including those facing the oil and gas industry and the renewables sector; supports a focus on improving productivity through innovation, investment, internationalisation and tackling inequality, and commits to take action in support of Scotland’s economy, including extending broadband, investing in infrastructure and building the skills and talents of Scotland’s people.

***S5M-00210 David Stewart: Support for Campbeltown Airport—**That the Parliament notes what could be the potential economic benefit to communities around the site that will be selected as the UK’s spaceport; understands that Campbeltown Airport is the only shortlisted site that fulfils the technical and safety requirements; notes that these include having a 3,000-metre runway, excellent storage facilities for large quantities of fuel and hazardous materials, room to expand over a 1,000-acre site, being situated in an area of low population density away from congested airspace, and acknowledges what it sees as the strong case being put forward by Discover Space UK for it to be selected as the site for the spaceport.

***S5M-00193 Murdo Fraser: 750th Anniversary of the Treaty of Perth—**That the Parliament welcomes the 750th anniversary of the Treaty of Perth; understands that the treaty, along with the Treaty of York set out much of the modern boundaries of Scotland; recognises that the treaty ended the military conflict between Magnus VI of Norway and Alexander III of Scotland over the sovereignty of the Hebrides and the Isle of Man; notes that Norway initially had control of the Hebrides and the Isle of Man after Edgar of Scotland signed them over to Norway; recognises that the Treaty of Perth was signed after Scottish victory at the Battle of Largs; believes that Norwegian

envoys sailed up the River Tay to meet the Scottish King and the treaty was sealed on 2 July 1266 at Blackfriars monastery on the north side of the city; understands that visitors to Perth can see the earliest surviving text of the treaty, recorded in the "Black Book", at Perth museum; notes the various civic activities taking place on 21 August in Perth to recognise the treaty's importance, which include a mini tattoo, complete with the King's Guard of Norway, and hopes that the commemoration of the Treaty of Perth can help foster closer links between the Fair City and Norway and also act as a focal point for attracting visitors to the city over the summer.

***S5M-00213 Elaine Smith: Driver-only Operation on ScotRail**—That the Parliament expresses its concern at reports that all ScotRail services will be driver-only operation with no guards; is dismayed that, as ScotRail is owned by the Dutch state railway, this means that profits will go to support Dutch railways while Scottish passengers endure staffing cuts; is also concerned that these developments are part of a wider breakdown in industrial relations and breach of agreements, which has now led to industrial unrest and possible strike action; is concerned that ScotRail management is simply dismissing passenger and staff concerns and promoting propaganda on social media rather than attempting to reach a negotiated settlement; believes that, at a time of record growth in passenger numbers, passengers want a guard on every train who can protect train safety, deal with emergencies, provide passenger advice, assurance and assistance and look after disabled and older passengers, and therefore calls on Abellio to withdraw its staffing cuts proposals and reach a negotiated settlement. **R**

***S5M-00211 Lewis Macdonald: Exhibition Celebrating Aberdeen's Support for Spanish Seamen**—That the Parliament welcomes the launch of a new exhibition at Aberdeen Maritime Museum, which marks Aberdeen's solidarity with the Spanish seamen's strike; understands that this exhibition, which runs from 28 May to 10 September 2016, tells the story of the Spanish steamship, Eolo, which berthed at Blaikie's Quay in Aberdeen in July 1936 and whose owners refused to comply with new Spanish legislation awarding seamen a pay rise; further understands that after the crew of the Eolo went on strike, they were supported by Aberdeen dockers and their families, who made collections on behalf of the 33 men for the duration of their 15-week strike before the owners of the ship made full payment to the crew; celebrates the efforts of Aberdeen trade unionists to support their Spanish fellow workers through the summer of 1936 and over succeeding years, and welcomes the decision by Aberdeen Maritime Museum to mark the 80th anniversary of the Eolo strike with an exhibition in the city.

***S5M-00209 David Torrance: Youth 1st Receives Big Lottery Fund Award**—That the Parliament congratulates Youth 1st, which is based in Kirkcaldy, on being awarded a grant of £49,969 from the Big Lottery Fund's Young Start Fund; recognises that this fund provides grants of between £10,000 and £50,000 to projects aimed at creating opportunities for people aged between eight and 24 to help realise their potential; understands that this grant will allow Youth 1st, through its B:Active Project, to set up taster sessions and provide training opportunities to promote physical activity and healthy lives to young people across Fife; further notes that young people will be given the opportunity to take part in youth advisory groups and organising events in their local area and that accredited training will be available to them; notes that this two-year

***S5M-00206 Murdo Fraser: Scientists' Call for GM Crops Rethink**—That the Parliament welcomes the reported comments by Professor Venki Ramakrishnan, the president of the Royal Society, that the ban on GM crops needs to be reassessed; understands that a recent report by the US National Academies of Sciences, Engineering and Medicine, which was based on 20 years of research, found no substantiated evidence of a difference in risks to human health between current commercially available GM crops and conventionally bred crops, nor did it find conclusive cause-and-effect evidence of environmental problems from the GM crops; notes the House of Commons Science and Technology committee report in February 2015 that called for reform of the regulations on GM crops and recommended that the UK Government publicly acknowledges that GM crops pose no greater inherent risk than their conventional counterparts, and believes that, given what it sees as the substantial scientific evidence, as well as the backing from prominent figures in the scientific community, it is time for the Scottish Government to reassess its approach to GM crops.

***S5M-00205 Lewis Macdonald: Kim Little Wins BBC Women's Footballer of the Year**

Award—That the Parliament congratulates Scotland's Kim Little on winning the BBC Women's Footballer of the Year Award for 2016, an international award organised by the BBC World Service; recognises that Kim, who was born in Aberdeen and started her footballing career at school at Mintlaw Academy, currently plays for Seattle Reign in the US, and has played 115 times for Scotland, scoring 46 goals; understands that Kim topped a worldwide supporters' poll to win the award, beating Gaelle Enganamouit (FC Rosengard, Sweden), Amandine Henry (Olympique Lyonnais), Carli Lloyd (Houston Dash) and Becky Sauerbrunn (FC Kansas City); notes that Kim is only the second winner of the BBC Women's Footballer of the Year Award, having previously won the FA's Women Player of the Year Award in 2010 and the inaugural PFA Women's Player of the

***S5M-00202 Liam McArthur: Battle of Jutland Centenary**—That the Parliament commemorates the centenary of the Battle of Jutland, which took place from 31 May to 1 June 1916; recognises that more than 8,500 people died in the largest naval battle in the First World War between the Royal Navy's Grand Fleet and the German High Seas Fleet off the coast of Denmark's Jutland Peninsula; further recognises that the battle involved over 250 ships, with Britain losing 14 and Germany 11 in the space of two days; acknowledges that many of the British ships involved in the battle were stationed at Scapa Flow in Orkney; welcomes the national commemorations taking place in St Magnus Cathedral in Kirkwall on 31 May; notes the Poppies: Weeping Window installation at the cathedral, which was originally displayed at the Tower of London; further notes that Orkney is the first place in Scotland to display the poppies, and congratulates all those who have been involved in organising the commemorations in Orkney.

***S5M-00201 Neil Findlay: UCU Striking for Fair Pay, Equality and an End to Casualisation**—That the Parliament notes the National Universities and College Union strike, which commenced on 25 May 2016 and will last for 48 hours; understands that this comes on the back of a derisory pay offer of 1.1% to university staff, while chancellors received a 5% rise last year; considers that there has been a gradual erosion of university staff pay, amounting to 14.5% since 2009, when the average vice-chancellor salary was £260,290 and who, on average, are paid 6.4 times more than the average staff salary; further considers that the gender pay gap in UK higher education is shameful with men, on average, earning 12.6% more than women; suggests that it is a disgrace that 75,000 university staff are on casual contracts with at least 21,636 on zero-hour contracts; hopes that universities will see sense and invest appropriately in their staff, and reminds chancellors and governments that "if you think education is expensive try ignorance".

***S5M-00198 Jackson Carlaw: Count Scotland's Armed Services Personnel in the Census—**That the Parliament believes that the 2021 Scottish census, which National Records Scotland is presently consulting on the content of, should include questions that pertain to the armed forces' community; considers that this would be of great value to government, public bodies and charities in providing a statistical basis on which to build service provision; notes that this proposal is supported by Poppyscotland and its parent charity, The Royal British Legion, along with many other organisations that are committed to the welfare of the armed forces; understands that, since the Armed Forces Covenant was enshrined in law in 2011, significant progress has been made in addressing disadvantage and providing special treatment where appropriate; believes that this proposal would allow for a statistical baseline of basic, but essential, information on which to build on this progress, including information regarding the number of veterans, reservists and their dependants and where they live; considers that this and other pertinent information could be collated for effective use, and, to ensure that government, charities and other organisations have the necessary data to deliver the dedicated care needed to deliver the dedicated care that the armed forces deserve, calls on National Records Scotland to include such questions in the census.

***S5M-00196 Lewis Macdonald: Congratulations to The Grill, Whisky Bar of the Year—**That the Parliament congratulates The Grill, which is on Union Street in Aberdeen, on winning the Whisky Bar of the Year award at the British Institute of Innkeeping (Scotland) Awards in Glasgow; understands that the bar, which was chosen on the basis of a secret visit from the institute's judges, offers a range of more than 500 whiskies, beat The Quaich in Craigellachie and Usquabae in Edinburgh to take the top prize; recognises that its history dates back to the 19th century and has been known as "The Grill" since 1870, and congratulates its owners, Andy Juroszek and Graham Watson, and all of the staff on this success.

***S5M-00195 Neil Findlay: Ken Cameron—**That the Parliament is saddened by the death of the former general secretary of the Fire Brigades' Union (FBU), Ken Cameron; notes his commitment to equality issues and his role as a champion of working people; believes that he was one of the great, progressive union leaders of his time, leading the FBU between 1980 and 2000; acknowledges his internationalism and strong commitment to many causes, such as support for the people of Cuba and Palestine and his opposition to apartheid, which led to Nelson Mandela becoming an honorary member of the union in 1990 and in Ken receiving a personal message of thanks from Mandela on his retirement; notes that, in 1982, he was the first union general secretary to bring a pro-Palestine motion to the Trades Union Congress and that this legacy continues through the FBU's continued support for the people of Palestine; understands that, when Margaret Thatcher was Prime Minister, he was credited with helping to protect the pay and conditions of firefighters and fought against moves to privatise the fire service; further understands that Ken was known for his close links with the National Union of Mineworkers and for the support that he gave to it during the year-long miners' strike; acknowledges that he was a Labour Party member and left-winger who got involved with the struggles of socialists and trade unionists in many countries, and notes that, asked for three words by which to be remembered, Ken insisted on four and then delivered five, "a socialist and a comrade".
