[S5M-02809](#) Ross Greer: Education—That the Parliament believes that professionals who provide additional support for learning play a vital role in Scotland's classrooms; welcomes international comparisons that demonstrate that Scottish schools are inclusive, but is concerned that public sector cuts threaten the opportunities that are available to children with additional support needs; notes that real terms revenue cuts to the Scottish budget have been disproportionately focused on local authorities, where education is the biggest spend, and that the number of additional support for learning teachers and support staff has fallen by 13% and 8% between 2010 and 2015, and calls on the Scottish Government to bring forward a budget that raises more revenue to support local educational priorities.

[S5M-02809.3](#) John Swinney: Education—As an amendment to motion [S5M-02809](#) in the name of Ross Greer (Education), leave out from “but is concerned” to end and insert “and recognises that, despite challenges, there remains a focus on enabling all children and young people with additional support needs (ASN) to reach their full potential through the approach taken in the Standards in Scotland's Schools etc. Act 2000 and the Education (Additional Support for Learning) (Scotland) Act 2004; acknowledges the increased achievements and attainment for young people with ASN since 2008; welcomes the Scottish Children’s Services Coalition’s call for greater collaboration and partnership working to deliver continued improvement in ASN provision, and commits to revising and updating the guidance on mainstreaming and the statutory guidance on the implementation of the additional support for learning framework.”

***S5M-02851 Mary Fee: Tackling Homophobia in Sport**—That the Parliament considers that there is a continuing existence of homophobia in Scottish sport; regrets that research by Stonewall Scotland states that 60% of sports fans had witnessed homophobic behaviour in the last five years, which is 9% higher than the rest of the UK; believes that it is important for sports personalities, coaches and sports clubs in the West Scotland region and across the country to challenge and oppose homophobia in all its forms to show that it has no place in Scottish sport; understands that there is a particular problem with homophobia in football, which is highlighted by the fact that there are no openly-gay, male professional footballers in the UK; commends the work of the Equality Network and its LGBT Sports Charter, which aims to set out the principles to make Scottish sport more inclusive, and welcomes the commitment of the SFA and sportscotland to tackle homophobia and LGBT discrimination in sport.

Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
