*S5M-07193 lain Gray: Freedom of Information, Scottish Government and Teach First—That the Parliament notes the reported difficulties in East Lothian and other parts of Scotland in recruiting teachers, especially primary head teachers and teachers of certain subjects such as physics and maths, but believes that solutions must maintain the principle of a fully trained and qualified teaching profession; therefore notes with concern what it understands has been communication between the Scottish Government and Teach First behind closed doors over a long period, involving two First Ministers and the Prince of Wales; regrets that these contacts were not made transparently and deplores what it understands is the refusal to publish correspondence and minutes of meetings relating to this matter under freedom of information legislation; is further concerned at any suggestion of policy being developed as a result of pressure, and notes calls on the Scottish Government to immediately publish all notes, minutes and correspondence regarding Teach First, including from or with its Patron, the Prince of Wales, in the public interest.

*S5M-07192 Alexander Stewart: Scotland's Charity Air Ambulance—That the Parliament acknowledges Scotland's Charity Air Ambulance (SCAA), which launched its life-saving operation in 2013; understands that the SCAA is based centrally at Perth Airport and considers that the distinctive Eurocopter (now Airbus Helicopters) EC135 T2i helicopter is ideally located to respond to time-critical emergencies all over Scotland; notes that Scotland is a country that accounts for a third of the UK landmass, with over 100 islands and some of the most remote communities in Europe; further notes that Scotland's first and only charity-funded air ambulance helicopter flies as and when tasked through the 999 service; understands that Scotland's trunk and rural road network, agricultural and other high-risk industries as well as rural, leisure and sporting pursuits, all offer the potential for time-critical emergencies in addition to the number of cardiac and stroke patients for whom rapid intervention is essential; considers the day-to-day workload profile of the frontline airborne team that responds effectively and efficiently, flying charity-funded vital emergency frontline clinical care straight to the heart of communities; considers that in attending nearly 1,500 individual missions and flying nearly 128,000 nautical miles since its inception in 2013, the SCAA has proved a vital part of the national emergency response framework and a highly valuable asset to the 999 cadre; is concerned that relying totally on charitable giving, the
