S5M-10648 Dean Lockhart: Campaign to Save ATMs—That the Parliament notes the campaign by *Which?* and the Federation of Small Businesses to call a halt to the potential closure of free-to-use ATMs across Scotland because of plans to reduce the interchange fee by the cashpoint network, LINK; recognises that ATMs are an important service in communities, particularly for people on low incomes, older people and in areas such as the Trossachs, Perthshire, Kinross and Fife; believes that this might exacerbate the problem of bank branch closures as some consumers might be left without access to even the most basic banking services; notes the calls for the Payment Systems Regulator to take action to prevent there being complete ATM absence in some areas, and acknowledges the view that assurances should be given that consumers and small businesses can maintain access to the network of free-to-use ATMs.

S5M-11984 Miles Briggs: NHS Financial Accountability—That the Parliament notes the financial problems in NHS Ayrshire, Tayside and Lothian; understands that these issues are being faced across Scotland; notes the ongoing lack of transparency on the state of board and integrated joint board finances; calls for the immediate publication of the current financial position for all NHS bodies and for a progress review of integrated joint boards, and believes that, failing sustained and immediate action, the Cabinet Secretary for Health and Sport should be held accountable for the ongoing problems.

[S5M-11539](#) Mark Ruskell: Civil Contingency in Nuclear Weapon Transport—That the Parliament understands that the Ministry of Defence regularly transports nuclear weapons on public roads in convoys that pass through or close to communities in the Argyll and Bute, Dumfries and Galloway, East Dunbartonshire, East Lothian, Edinburgh, Falkirk, Glasgow, Midlothian, North Lanarkshire, Renfrewshire, Scottish Borders, Stirling, South Lanarkshire, West Dunbartonshire and West Lothian local authority areas; believes that there is an inherent risk in transporting high explosives and radioactive material together on public roads; understands that information on what to do in an emergency involving a nuclear reactor is regularly circulated to residents close to the Coulport and Faslane bases but that no equivalent information relating to an incident involving nuclear weapons is available to communities along the regular convoy route; believes that although defence is a reserved matter, it would be for the civil authorities such as police, fire and rescue and local authorities to attempt to respond to any emergency as so-called category 1 responders, and notes the view that these civil authorities must have sufficient assessments and plans in place to respond.

***S5M-11987 Ash Denham: Neurofibromatosis Awareness Month**—That the Parliament recognises that May is Neurofibromatosis (NF) Awareness Month, and that World NF Awareness Day is 17 May; notes that NF is a genetic condition caused by a mutation in one of the genes and that it is a term for a group of conditions mainly affecting the nervous system and skin; acknowledges that there are differences in the three main groups, NF type 1 (NF1), NF type 2 (NF2) and schwannomatosis; is aware that tumours throughout the body caused by NF are usually not malignant, but they may cause other issues when they grow in the brain, on the spine or against body tissue; notes that, at present, there is no known cure, and that the third type, schwannomatosis, has very little known about it; appreciates that, in relation to NF affecting children, the symptoms are wide ranging and may be mild or severe; congratulates everyone who is undertaking various and unique activities during May to raise awareness of NF; welcomes the work and support from charities such as Funny Lumps, The Neuro Foundation and The Childrens Tumour Foundation; remembers the incredibly determined Beth Beattie, who sadly passed away from the condition on 4 November 2016, aged four, and hopes that, across the UK, in all NHS boards, including NHS Lothian, NF patients will receive regular routine monitoring by specialists.

***S5M-11986 Alison Johnstone: Stop the Raven Cull**—That the Parliament expresses concern that Scottish Natural Heritage (SNH) has granted a licence to the Strathbraan Community Collaboration for Waders, which authorises the killing of 300 ravens; notes that this will take place in an area of Perthshire where eagles, which have been satellite-tagged have, it understands, previously disappeared and where the illegal persecution of raptors is believed to be well-documented; understands that this is as part of an experiment, which reportedly has no control measure in place, to assess the impact of such a cull on the wader population; regrets what it sees as the lack of consultation with expert organisations, including the Scottish Raptor Study Group and the RSPB; understands that these groups maintain that there “is no justification for this extreme course of action”; believes that there is a lack of robust scientific evidence to support this action; understands with regret that it is only now, following a notable and concerted public outcry, that SNH is calling on its Scientific Advisory Council to scrutinise the cull, and calls for the withdrawal of the research licence and the removal of the open general licence in this area as a matter of urgency.
