***S5M-13785 Colin Smyth: Ban on the Export of Live Animals for Slaughter and Fattening**—That the Parliament notes the Farm Animal Welfare Committee's review into the transportation of live animals exports from the UK; understands that in 2017 3,073 sheep, 5,595 calves and 661 cattle were exported from Scotland for either slaughter or fattening; considers that Scotland's reputation for high animal welfare standards is of huge value to the sector; is particularly concerned about the export of young male dairy calves on long journeys to Spain and Italy where they are fattened for beef or veal; recognises what it understands is widespread support for a ban on the exporting of animals for slaughter and for fattening, including in the South Scotland region, and the serious concerns raised by the export of live animals in relation to animal welfare, and notes calls on the Scottish Government to bring forward a ban on the export of live animals for slaughter or fattening.

***S5M-13776 Kenneth Gibson: 90th Anniversary of the Discovery of Penicillin**—That the Parliament recognises that 3 September 2018 marked the 90th anniversary of the discovery of penicillin by Sir Alexander Fleming, the renowned Scottish physician and pharmacologist born in Darvel, Ayrshire, who found that it produced a substance that killed a number of disease-causing bacteria, naming this penicillin on 7 March 1929; understands that, by 1944, enough penicillin had been produced to treat all the wounded in the allied forces; is aware that, prior to this discovery, there were no effective treatments for infections such as pneumonia, gonorrhoea or rheumatic fever, and that Fleming's work marked the beginning of modern antibiotics; values the incalculable contribution made to modern medicine and society by Fleming and his colleagues, which was formally recognised in 1945 when Fleming, Howard Florey and Ernst Chain jointly received the Nobel Prize in Medicine; believes that, while it is impossible to know how many lives have been saved by penicillin, estimates exceed 200 million, and believes that Fleming's revolutionary contribution to humanity should be celebrated for generations to come.
