### Members' Business motions that have achieved cross party support

**\*S5M-14126 David Torrance: Fife Alcohol Support Service, Supporting Fifers for 40 Years**—That the Parliament commends Fife Alcohol Support Service (FASS) on its 40th year of helping people overcome issues with alcohol; understands, that since it was founded, 200 counsellors have supported over 23,000 Fifers and their families to help them deal with addiction; notes that this counselling is provided in health centres, surgeries and community venues across the Kingdom; acknowledges the merger of the Fife Community Drug Service with FASS in 2015 to help provide outreach support and help for vulnerable people affected by both alcohol and substance misuse problems, including specialist help for recreational drug users and people who misuse prescribed medication; praises FASS's Curnie Clubs, which tackle isolation and loneliness through work with dedicated project workers who identify need and barriers to change and help people engage in community-based social activities that help them to find their way back into community life; recognises what it sees as the relationship between isolation and loneliness and their association with physical and mental health issues and drug and alcohol problems; commends FASS on its invaluable work with some of the most vulnerable in Fife, and wishes it all the best.

**\*S5M-14123 Monica Lennon: South Lanarkshire Care Homes Under Threat**—That the Parliament understands that South Lanarkshire Council plans to reduce the number of its care home facilities; notes that the first phase of these plans includes the closure of McWhirter House in Larkhall and Kirkton House in Blantyre; considers that the proposed new community hub facility at the St Joseph's site in Blantyre is not a like-for-like replacement and that this will result in a reduction in the number of long-term residential beds; understands that the closure of McWhirter House will leave Larkhall with no council-run care facilities for older people; believes that council-run care provision must remain a vital part of the delivery of residential care for older people and that the ageing population requires a shift in the model of care in South Lanarkshire and the Central Scotland region; recognises that the reliance of the older population on care is likely to

increase in coming decades; acknowledges calls that this should be achieved without a reduction in the availability of long-term council care beds and with the support of the community; is concerned at reports that there has not been meaningful consultation with care home staff, trade unions or the communities that are affected by the plans; acknowledges in particular the concerns raised by the GMB, and notes the calls for the SNP administration in South Lanarkshire to halt the planned closures. **R**

**\*S5M-14137 Jenny Gilruth: Project 70 to Light Up Town's Art and Heritage**—That the Parliament welcomes the preparations of Project 70 in Glenrothes, which will take a look back in history and art heritage with a visual spectacle to celebrate the town's 70th anniversary; notes that this is a free, one night only event, which is set to light up Kingdom House, one of Glenrothes's most prominent buildings, in October 2018; understands that the project creator, Aaron Andrews', aim was to create something that had not been done in Glenrothes before and thought that, with 2018 not only being the 70th anniversary of the town but also the 50th anniversary of David Harding becoming the country's first town artist, it was the perfect time to give people a visual and musical event like no other; recognises that this visual show will be projected onto the gable end of Kingdom House in the town centre, which is a perfect backdrop with the celebrated sculpture of birds situated below, and wishes Aaron and those who are a part of Project 70 the best of luck on the night, and with their future projects.

**\*[S5M-14133](#) Claire Baker: Save Tullibody Civic Centre and Tullibody Healthy Living**—That the Parliament expresses concern at the decision by Clackmannanshire Council to close Tullibody Civic Centre and remove staff from the facility on 30 September 2018; understands that this is despite ongoing discussions with Tullibody Community Development Trust (TCDT) regarding the community takeover of the building, which is used on a daily basis for a range of activities and hires, including by many long-term users; understands that the local authority commissioned an external company, NIFES, to undertake a survey of the building in 2014; believes that the subsequent report was highly critical of the council for neglecting the building and concluded that there was a need for an investment of £640,000 to carry out essential repairs and upgrades to bring it to an acceptable standard; believes however that the council has failed to carry out any of the report's major recommendations, maintaining the building on a "wind and watertight" basis only; commends TCDT on what it sees as its commitment and vision for trying to secure a long-term future for the civic centre and its efforts in trying to get the council to take responsibility for what it considers to be years of underinvestment by committing to carrying out the recommendations in the NIFES report in addition to carrying out any other further improvements that are now necessary; understands that Tullibody Healthy Living (THL) has also received notification of the removal of its core funding from the council; believes that this will result in the closure of services and job losses at what it considers to be a vital third sector organisation, and calls on the council to enter into meaningful engagement with TCDT and THL to ensure that the support is provided to avoid what it believes would be the devastating impact that the closure of either would have on the Tullibody community.

**\*[S5M-14132](#) Claudia Beamish: Healthy Valleys Tackling Poverty in Clydesdale**—That the Parliament understands that 2018's Challenge Poverty Week provides an opportunity to congratulate charitable organisations such as Healthy Valleys, which is helping transform communities in rural Clydesdale by working with them to solve problems; recognises that this work builds resilience and empowers communities to find solutions and tackle and relieve the impact of poverty, particularly on children, vulnerable adults and older people; commends the practical support and opportunities that it provides to help improve people's circumstances, such as child health and wellbeing programmes, parental support and social prescriptions; believes that this helps engage those most hard to reach to participate equally and actively in community life, and commends its community health cafes, which are led by volunteers and ensure that everyone is able to access healthy, nutritious meals and are signposted and supported to access a variety of support to help alleviate poverty, improve health and wellbeing, and reduce isolation and loneliness.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
