## 12:45 pm Members' Business — S5M-15230 Willie Coffey: Congratulations to Kilmarnock FC on its 150th Anniversary

**S5M-15230 Willie Coffey: Congratulations to Kilmarnock FC on its 150th Anniversary**—That the Parliament congratulates Kilmarnock FC, the oldest professional football club in Scotland, on its 150th anniversary; notes that the first recorded general meeting of the club took place on 5 January 1869 in the Temperance Hotel in Kilmarnock, notified by secretary, John Wallace; recognises the many achievements of the club, which include becoming one of the first clubs to contest an official Scottish Cup match along with Renton in 1873, winning the Championship under the manager Willie Waddell in 1965 by defeating Hearts 2-0 on the last day of the season to win the league on goal average by 0.042 goals, winning the Scottish Cup in 1920 by defeating Albion Rovers 3-2 and again in 1929 by beating Rangers 2-0 and in 1997 defeating Falkirk 1-0, winning the League Cup in 2012 by beating Celtic 1-0, winning the Ayrshire Cup 42 times, recording 189 victories out of 256 meetings with local rivals, Ayr United, regularly representing Scotland in the New York International Tournament in the 1960s, qualifying for European competitions on nine occasions, notably defeating Eintracht Frankfurt 5-4 on aggregate in the club's first European tie in 1964 after being four goals down, welcoming Real Madrid to Rugby Park as league champions in 1965, drawing 2-2, and reaching the semi-final of the Inter Cities Fairs Cup in 1966-67 against Leeds United; recognises that the club is enjoying its 26th season in a row in the top flight in Scotland; notes that the club recorded the highest points tally of 74 points in the calendar year 2018, and sends the club, staff and supporters its best wishes for the year ahead and for many years to come.

### Members' Business motions that have achieved cross party support

**\*S5M-15746 Miles Briggs: Parkinson's in Scotland**—That the Parliament understands that Parkinson's is the second most common neuroprogressive condition after Alzheimer's; recognises that it has a profound impact on people with the condition, and their close friends and family; welcomes what it sees as a comprehensive new report from Parkinson's UK, *People. Parkinson's. Scotland. What do we know about services and support for people with Parkinson's in Scotland?*; notes with concern that it suggests that there are about 12,400 people in the country with the condition and that this is expected to increase by 40% within 20 years; acknowledges the view that the Scottish Government, NHS boards and health and social care partnerships must plan now to meet the care needs of the growing number of people with Parkinson's; accepts that it is a very complex condition with over 40 recognised symptoms, which can affect every aspect of daily living and can require ongoing support from a multidisciplinary team of health professionals; understands with concern that 10% of neurologist and medicine for older people consultant posts in Scotland is currently vacant and that waiting times are growing; believes that Scotland has fewer Parkinson's nurses than it needs and that, in NHS Lothian, NHS Lanarkshire, NHS Highland and NHS Forth Valley, there are reportedly about half the number of required nurses; understands that around one in every five people with the condition has extremely high levels of care need; believes that it can be challenging for people with Parkinson's to access the information, care and support that they need to maintain their independence and prevent emergency hospital and care home admissions; celebrates what it sees as the excellent work that is carried out by NHS and social care professionals across the country to provide better support for people with Parkinson's and their carers, including as members of the UK Parkinson's Excellence Network, and applauds the efforts of Parkinson's UK's small team of staff and over 300 volunteers to support everyone in Scotland who is living with the condition.

- (3) Subsection (1) does not apply where the planning authority are satisfied, on information provided by the applicant, that—
  - (a) there is good reason why provision for fibre-to-the-cabinet cannot be made for the development, and
  - (b) in the circumstances it is reasonable that subsection (1) should not apply.
- (4) In this section “fibre-to-the-cabinet” means connectivity technology that is based on a combination of a fibre optic cable from the local telephone exchange to a distribution point and from the distribution point a copper telephone line to the development.”.>

## Members' Bills Proposals

### Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
