## Members' Business motions that have not achieved cross party support

**\*S5M-15536 James Kelly: Threatened Closure of the St Rollox Railway Works**—That the Parliament regrets the threatened closure of the St Rollox Railway Works, which is known as the Caley, by its new owners, Gemini Rail Services; believes that this places 200 highly-skilled jobs in Springburn at risk; understands that the workers have been served with a statutory notice and that a 45-day consultation period has been initiated; notes that a debate was held on the proposed closure in the UK Parliament, which was led by the MP for Glasgow North East, Paul Sweeney, on 14 January 2019; acknowledges the Unite campaign, Rally Roon the Caley, which is calling for onsite electrification to connect the depot to the Glasgow-Edinburgh rail line; notes the expressions of solidarity that have been sent to the workers at the Caley, and acknowledges the calls for the Scottish Government to do all that it can to secure this site, which has served Scotland's railways since 1856.

**\*S5M-15519 Colin Smyth: Report on Beating High Blood Pressure**—That the Parliament welcomes the publication of the report, *Beating High Blood Pressure: Scotland's Silent Killer*, which has been produced by the Cross Party Group on Heart Disease and Stroke; notes that it recognises that high blood pressure affects 30% of adults across the country, including many in South Scotland, and increases a person's risk of stroke and heart disease; acknowledges the recommendations in the report, and thanks the members of the advisory panel who supported and informed the formation of the report and its recommendations.

- (1) Where, in order to comply with the duty under section 12IA, a Health Board or the Agency secures the services of an agency worker (within the meaning of the Agency Workers Regulations 2010), that Health Board or the Agency (as the case may be) must comply with subsection (2).
- (2) The maximum amount to be paid to secure the services of that worker during a period must not exceed 150% of the amount that would be paid to a full-time equivalent employee of the Health Board or the Agency to fill the equivalent post for the same period.
- (3) In exceptional circumstances, a Health Board or the Agency may apply to the Scottish Ministers for authorisation to pay an amount higher than the amount prescribed in subsection (2).
- (4) As soon as reasonably practicable after the end of each financial year, the Scottish Ministers must publish information on—
  - (a) the number of applications they received under subsection (3) in that financial year, and
  - (b) the number of such applications that were authorised.>
