S5M-15264 Richard Lyle: Remembering the Holocaust—That the Parliament recognises that 27 January 2019 is Holocaust Memorial Day; believes that the day is an important opportunity to reflect on the tragedy of the Holocaust and the atrocities committed during the times of Nazi rule in Germany; remembers that approximately 17 million people lost their lives during this dark time with 6 million of those being Jews; considers that the pain, suffering and sorrow that was caused comes from views rooted in hatred and prejudice and perpetrated by those with dangerous thoughts of superiority; acknowledges that it has almost been 70 years since the Holocaust; reiterates its condemnation of the actions of those involved, and supports the victims of this and other genocides throughout recent history; commends all service personnel who fought in defence of liberty, freedom and justice, especially those who paid the ultimate sacrifice, and reiterates its commitment to condemning any antisemitic action or language present today and defending all ethnic groups that are oppressed and persecuted throughout the world.

***[S5M-15541](#) Bob Doris: Efforts to Save St Rollox Railway Works**—That the Parliament expresses its dismay and disappointment at the reported proposal by Gemini Rail Services to close the St Rollox Railway Works, which threatens the employment of up to 200 highly-skilled workers in Springburn; considers that the St Rollox site has had a proud history within the world locomotive industry since 1856 and is still affectionately known as "the Caley"; understands, however, that its future is now under threat as a result of Gemini serving a statutory notice regarding redundancies, and that a 45-day consultation period has now commenced; regrets that the company has taken this course of action, which it believes is likely to reduce the time period within which to identify and implement solutions to save both jobs and operations at the site; acknowledges the formation of a stakeholder group in December 2018 by the Scottish Government, chaired by the transport secretary, which aims to save St Rollox Railway Works; notes that this stakeholder group was established following representations made to the First Minister on 13 December 2018 at First Minister's Questions, and understands that there have been proactive efforts to save St Rollox Railway Works, including the Unite campaign, Rally Roon the Caley, which has made a number of suggestions such as the electrification of the track into the site to reduce business costs and the identification of contract work for the order book to allow the lifespan of St Rollox in its current form to be extended, and allow time for further work to restructure or diversify activities at the works.

expected to boost visitor numbers from 3,000 to 12,000 per year; understands that the museum displays one of Scotland's premier collections of Roman artefacts, which were uncovered during excavations at the site of the Roman fort near Newstead at the beginning of the 20th century, many of which are now on display at the National Museum of Scotland; acknowledges the prominent role that Trimontium played within Roman Scotland, as a major Roman staging post on Dere Street, providing an important halfway point between Hadrian's Wall and the more northerly Antonine Wall; notes that the museum secured funding through the National Lottery and is set to apply for more money in March 2019; acknowledges that construction work is due to start in the summer of 2020 and that the expanded museum is expected to open in the second quarter of 2021; recognises the dedicated work of a small group of volunteers who have played an essential role in preserving this remarkable piece of Romano-Celtic history, and thanks all those involved for their committed service to the museum during its 28 years of operation.
