***S5M-18311 Gillian Martin: Methlick Cycle Challenge Raises £3,500 for Local Good**

Causes—That the Parliament congratulates the organisers of the Methlick Cycle Challenge on the success of the 2019 event; understands that over 100 cyclists between the ages of nine and 73 took part in the challenge; notes that this included three routes of 70 miles, 40 miles and a family-friendly 20-mile option; recognises that the event raised over £3,500, which will be distributed among local good causes; believes that events such as this help bring communities together as well as encourage physical wellbeing; commends the organisers on their efforts, and wishes all those involved well.

***S5M-18304 Neil Findlay: Surge in Foodbank Demand in West Lothian**—That the Parliament notes the reported 41% surge in demand for the services of West Lothian Foodbank over the last year; considers that this is a result of the number of people in poverty increasing as the income of lower income households falls further behind that of middle and high income households over the last three years, and calls on the Scottish and UK governments to directly address this problem by committing to a radical redistribution of power and wealth in Scotland.

***S5M-18303 Neil Findlay: Lewis Capaldi Pays Tribute to Robbie McArthur**—That the Parliament notes that the Whitburn singer, Lewis Capaldi, performed his chart topping hit, *Someone You Loved*, at the recent TRNSMT festival in Glasgow in tribute to Robbie McArthur from Lochgelly in Fife; notes that Robbie took his own life in May 2019 and his family and friends subsequently launched an online bid to get Lewis to perform the song in tribute to his life; recognises that suicide has a lasting impact on the lives of loved ones and friends, and congratulates all those who are working hard to lift the stigma of depression and mental health problems so that people can get the treatment they need.

***S5M-18302 Neil Findlay: West Lothian Drug Deaths Soar**—That the Parliament expresses its deepest concern that the number of deaths as a result of drugs in West Lothian has, it understands, increased by over 66% since 2015, with 25 people dying in 2018 as a result of drug use in the county; believes that the impact these deaths have on communities and families is devastating and that everything should be being done to prevent it; understands that this reflects a wider trend in Scotland, which has seen the country record the highest level of drug deaths in the EU, and calls on the Scottish and UK governments to begin treating drug use as a public health problem and the process of decriminalising drug use so that drug dealing and dealers can be tackled, not drug users, while investing in improving services and treatment.

***S5M-18301 Liam Kerr: Hydrogen Buses for Aberdeen**—That the Parliament welcomes the news that Aberdeen is to be the first city in the world to introduce hydrogen-powered double decker buses; understands that the new buses will be more efficient than their electric equivalents, and that refuelling will only take 10 minutes; notes that the new buses will reduce carbon emissions and help tackle air pollution; believes that these new additions demonstrate Aberdeen's commitment to being a world leader for energy innovation and technology, and hopes to see more cities across the UK follow Aberdeen's example.

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no indication is given that the Scottish Government or UK Government is planning equivalent legislation.
