awareness of the threat facing curlew species around the world; understands that the curlew population in Scotland has declined by 61% since 1994, mainly as a result of the loss of habitats; recognises the need for ongoing monitoring of the efficacy of conservation schemes for waders, including the curlew; commends the efforts of the Working for Waders initiative in supporting curlew conservation projects across Scotland; welcomes the contributions to curlew conservation that have been made by farmers and land managers, and calls for continued financial support for schemes that work to restore curlew numbers in Scotland.

***S5M-17163 Kenneth Gibson: Infra-red Camera System Donated to Arran Mountain Rescue Team**—That the Parliament acknowledges the donation of a hand-held infra-red camera system to Arran Mountain Rescue Team by Thales, a company based in Glasgow, on 30 April 2019; understands that the camera system, worth approximately £30,000, will assist the volunteer members of Arran Mountain Rescue Team by providing day and night vision capabilities as they endeavour to assist people who have got into difficulty in the hills and mountains of Arran; recognises that Thales started in Glasgow as Barr & Stroud as a pioneering optical engineering firm in 1888 and has contributed significantly to Scotland's engineering sector since then; notes that Arran Mountain Rescue Team is made up of men and women from all over the island, all volunteers, who give up their time freely when an emergency arises, and is grateful for the generosity of Thales in supporting the lifesaving work of the rescue team.

***S5M-17162 John Scott: Congratulations to Ayr Rugby Football Club**—That the Parliament congratulates Ayr Rugby Football Club on winning the Scottish Premier League, the SRU Championship Cup, the SRU National Cup and the Bill McLaren Shield in the 2018-19 season; further congratulates the players, the coaching staff, office bearers and the many volunteers who support the club on a daily basis; recognises that the club has 584 playing members, including men, women, boys and girls, including approximately 400 boys and girls from age seven upwards, and wishes Ayr Rugby Football Club every success in the new Super 6 League next season in which Ayr, Boroughmuir, Heriot's, Melrose, Stirling and Watsonians will be representing Scotland.

***S5M-17161 Lewis Macdonald: Archibald Leitch Link to Pittodrie Discovered**—That the Parliament recognises the recent discovery that the radical reconstruction of Pittodrie Stadium in Aberdeen in the 1920s was the work of Scottish architect, Archibald Leitch; understands that the discovery was made by Aberdeen supporter, Sue Shepherd, whose painstaking research succeeded despite the fact that Aberdeen FC's own records had been destroyed in a fire in 1971; recognises that Archibald Leitch was also responsible for the design of many other great stadiums between 1899 and 1939, including Hampden Park, Old Trafford, Anfield, Cardiff Arms Park and Lansdowne Road; acknowledges the important contribution that Glasgow-born Leitch made to football architecture across the country, and commends Sue Shepherd, as well as the AFC Heritage Trust, Aberdeen City Archives and others who helped her to establish the origins of the design of Pittodrie Stadium.

***S5M-17160 Alex Rowley: Budget Cuts Bite Fife Food Inspections**—That the Parliament is deeply concerned by the news that nearly half of Fife food premises are reportedly currently awaiting inspection following a recent audit that showed a backlog in the number of food premises inspections; acknowledges that Food Standards Scotland carried out checks in August 2018, which found that 2,283 out of 4,325 food premises were waiting to undergo inspection, while

another 272 were unrated as they had yet to be inspected; understands that the audit showed that 60 premises were in the "high risk" A and B categories, with a further 114 in category C, 766 in category D and 1,343 in category E; notes that the audit report found that environmental health resources, including staffing, for conducting official controls was "insufficient" to achieve the requirements of the Food Law Code of Practice (Scotland) 2015; recognises that the report also states that budget information for food activities produced by Fife Council appear to show a reducing allocation of finance to the service, falling steadily from £635,000 in 2014-15 to under £500,000 in 2018-19; considers that Fife Council must do all that it can to ensure that food premises are inspected to ensure that high standards of food hygiene are in force for customers of food premises across Fife, and further considers that cuts to local authority budgets should not impact customers of food premises in Fife in relation to food safety and food hygiene.

***S5M-17150 Jackson Carlaw: Hungary's Annual March of the Living Dedicated to the Scot, Jane Haining**—That the Parliament acknowledges that the 2019 Annual March of the Living, Hungary's annual Holocaust Memorial Day, was held in Budapest on 14 April and was dedicated to the Scottish missionary, Jane Haining, who paid the ultimate sacrifice for protecting Jewish children during the Second World War; remembers the courage and bravery of Jane, who first ignored warnings to return to Scotland in 1940, and then again in 1944 after Hungary was

invaded; recalls that she famously wrote that she would not leave the children in her care during days of darkness; acknowledges that Jane was arrested in March 1944 and was subsequently murdered at Auschwitz-Birkenau, aged just 47; recognises that she is the only Scot to be honoured as "righteous among the nations" at the Yad Vashem Holocaust Memorial Centre in Jerusalem, which is a title bestowed on non-Jewish people who risked their own lives to protect Jews during the Second World War, and that her name is rightly inscribed on the walls of honour at the Garden of the Righteous, and agrees that the decision to dedicate the 2019 annual march to her memory was a fitting tribute to the personal self-sacrifice that Jane made to protect Jewish children.
