**\*[S5M-19234](#) Maurice Corry: Commonwealth War Graves Commission**—That the Parliament recognises the work of the Commonwealth War Graves Commission in honouring the 1.7 million men and women of the Commonwealth forces who died during the First and Second World Wars, through construction and perpetual maintenance of war cemeteries, memorials and plots; understands that this work consists of immaculately planned and groomed landscapes and the conservation of headstones and memorials through teams of specialists around the world; acknowledges the extensive effort that the Commonwealth War Graves Commission makes to properly identify and respectfully bury all remains, ensuring that every individual is memorialised by name whether it be on a personal headstone or memorial; commends these vital efforts by the Commission in remembering the fallen; understands that over 175,000 Scots are respectfully commemorated and remembered by the commission in foreign countries, while over 20,000 of the total war graves cared for by the commission are spread across 1,200 locations in Scotland, including in West Scotland, and notes calls for all MSPs to join the Commission in its active remembrance of all those who paid the ultimate price.

**\*[S5M-19221](#) Alex Rowley: A Menu for Change's Report, Found Wanting**—That the Parliament welcomes the report by A Menu for Change, *Found Wanting*, which looked at the pressures forcing people into food insecurity in Scotland; understands that A Menu for Change is a three-year initiative that is run by Oxfam Scotland, Nourish Scotland, the Child Poverty Action Group in Scotland and the Poverty Alliance and is funded by the National Lottery Community Fund; notes that its research was carried out in Fife, East Ayrshire and Dundee and tracked people with lived experience in and out of food insecurity; believes that, while these people said that they found great support from community groups and the healthcare and education sectors, the report found that system changes are required to prevent the causes of food insecurity; understands that income shocks from insecure and inadequate wages from employment and social security are key drivers in pushing people to become food insecure; notes the report's recommendations for a review of the budget for the Scottish Welfare Fund, for the Scottish Government to use public procurement to deliver fair work and invest in low-paid sectors and to ensure that devolved

employability programmes are designed to provide person-centred support for people who are furthest from the labour market; recognises the significant barriers that people facing food insecurity can face, and, in doing so, notes the authors' recommendations for UK ministers to restore the value of key benefits, uprate all benefits in line with inflation, remove the two-child limit and benefit cap, eliminate measures creating income shocks, including the five-week wait for universal credit, and to improve in-work conditions through measures such as increasing the national living wage to the real living wage, banning exploitative zero-hours contracts and improving in-work support.

Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
