***[S6M-00768](#) Miles Briggs: SCVO Creates its 10,000th CJS Job in Scotland's Voluntary Sector**—That the Parliament recognises and celebrates what it sees as the continued success of the SCVO-run Community Jobs Scotland (CJS) employability programme as it creates its 10,000th job; understands that CJS provides paid jobs for young people, with targeted efforts to help those who are disadvantaged and vulnerable; believes that its model and approach has been incredibly effective in ensuring that young people who face particular challenges, such as having caring responsibilities, being care-experienced, holding criminal convictions, leaving the armed forces early or living with disability, are given the opportunity to take their first steps into employment; notes that CJS was established in 2011, when levels of youth unemployment were high; acknowledges that, over this time, phases 1 to 11 of the programme have created paid jobs for 10,049 young people, with an average of 54% being retained by their employer after their initial job had ended, and 64% recording positive outcomes into jobs, volunteering or education; welcomes CJS's adoption of a competitive application and interview process before a young person is offered a job and considers that this, alongside compliance with employer policies and procedures, is extremely important in terms of instilling a sense of belonging in a real work environment; understands that phase 11, which is currently underway, will support up to up to a further 560 opportunities for vulnerable young unemployed people aged up to 29 through a range of voluntary sector organisations across all 32 local authority areas; welcomes the recent announcement of the 10,000th CJS job, which will see a young person take on the role of Creative Assistant with Impact Arts (Projects) Limited for 40 weeks, and looks forward to further opportunities opening up with CJS, to help support vulnerable young people in the Edinburgh region and across Scotland who face significant barriers, but who deserve to play their full role in society.

***[S6M-00786](#) Carol Mochan: Open Doors Community Hub, Kilmarnock**—That the Parliament commends the crucial work carried out by Open Doors Community Hub in Kilmarnock; understands that Open Doors provides recovery programmes and opportunities for people struggling with addiction, offers foodbank provision for people in need and takes part in regular community "walkabouts" with community police officers to develop an understanding of the real lived experiences of people in the area; understands with concern that, on average, between 2015 and 2019, 0.22 deaths per 1,000 of the population in East Ayrshire were drug related, which is higher than the Scottish average; considers that cooperative working between community police officers, community groups and charities is a positive step towards tackling addiction, and calls on the Scottish Government to do more to support groups, such as Open Doors, that are contributing significantly to Scotland's response to the drug-deaths crisis.

***[S6M-00785](#) Marie McNair: Opening of Scotland's First National Treatment Centre at the NHS Golden Jubilee in Clydebank**—That the Parliament acknowledges the opening of Scotland's first National Treatment Centre at the NHS Golden Jubilee in Clydebank; understands that the NHS Golden Jubilee Eye Centre is part of the planned expansion of the hospital, with work on the second phase already underway and the new Surgical Centre expected to be completed by June 2023; notes that the Eye Centre, which has been operating since November 2020, has increased the number of ophthalmology procedures undertaken at the NHS Golden Jubilee by almost 47%, and applauds all staff in the hospital for their continuous hard work.

***[S6M-00781](#) Liam McArthur: World's Most Powerful Tidal Turbine Starts Generation in Orkney**—That the Parliament recognises the start of electricity generation by the Orbital O2 tidal turbine in Orkney; understands that the 680-tonne tidal turbine, built in Dundee by Orbital Marine Power, is considered to be the world's most powerful and has the capacity to meet the annual electricity demand of 2,000 homes for the next 15 years; notes that it is anchored in the Fall of Warness at the European Marine Energy Centre (EMEC) and is connected to the grid in Orkney where it will help power communities cleanly and sustainably from the strength of the waters that flow past the islands; recognises Orkney's world-leading role in the development of renewable technology and importance in helping Scotland achieve its net-zero and climate targets, and congratulates Orbital Marine Power and EMEC on the safe and successful delivery of this pioneering renewable energy project.

***[S6M-00780](#) Sharon Dowey: Duncan Scott's Olympic Success**—That the Parliament recognises the achievements of Duncan Scott, who has won both a gold and silver medal for Team GB at the Tokyo Olympics; notes that Duncan was taught to swim in Troon by his father before joining South Ayrshire Swim Club; understands that Duncan became Scotland's first Olympic medallist at this year's games, claiming silver in a thrilling 200m Freestyle swimming event final at the Tokyo Aquatics Centre, setting a personal best and Scottish record time of 1:44:26; understands that Duncan's silver medal win was the first time since 1908 that two male British swimmers have finished on the Olympic podium together, and wishes Duncan further success in his already impressive career.

***S6M-00779 Douglas Lumsden: Aberdeen and Aberdeenshire Host Final Stage of 2021 Tour of Britain**—That the Parliament congratulates Aberdeen and Aberdeenshire on being the hosts of the final stage of 2021's Tour of Britain, the UK's biggest professional cycling race, on 12 September 2021; notes that the 173km stage starts in Stonehaven, enters the Cairngorms by climbing the famous Cairn O' Mount mountain pass, progresses through Ballater and heads into the city finishing on Aberdeen's beach esplanade, where the overall 2021 Tour winner will be crowned; further notes that Aberdeen and Aberdeenshire will host the Grand Départ, the first stage, of the 2022 Tour; understands that the race will attract top riders and teams, allowing local spectators the chance to see some of the best athletes in the world; believes that this will help attract visitors to Aberdeen and Aberdeenshire, which will boost the local economy; hopes that this will encourage active sporting participation in the North East and beyond, and wishes the organisers all the best for the event.

***S6M-00778 Alexander Stewart: 10th Anniversary of Sarcoma UK and Sarcoma Awareness Month**—That the Parliament acknowledges that, in 2011, the Sarcoma Trust and Sarcoma UK joined to become a new single charity for sarcoma patients, carers and relatives in the UK, retaining the Sarcoma UK name; understands that, 10 years on, Sarcoma UK has invested more than £4.3 million into scientific and medical research, supported almost 2,500 people through the Sarcoma UK Support Line, and worked with national governing bodies, sarcoma specialist centres and organisations to advocate for better and earlier treatments for people affected by sarcoma; acknowledges that, to mark its 10th anniversary, the charity wants the public to join it in reflecting on the progress that it has made together with its volunteers, fundraisers and patients, as well as celebrate the achievements and remember the people who have made, and continue to make, Sarcoma UK, and look to a future where everyone affected by sarcoma cancer has the treatment, care and support that they need; notes that Sarcoma Awareness Month has been running for the whole of July, and does so each year, in order to raise awareness of sarcoma and to encourage the raising of valuable funding; understands that sarcomas are rare cancers that develop in the muscle, bone, nerves, cartilage, tendons, blood vessels and the fatty and fibrous tissues, but can affect almost any part of the body; notes that sarcomas commonly affect the arms, legs and trunk, but can appear in the stomach and intestines, as well as behind the abdomen and the female reproductive system; understands that bone sarcomas affect less than 500 people in the UK each year, making it a very rare form of cancer, and that not all bone cancers will be sarcomas; is encouraged that it is possible to survive sarcoma if the cancer is diagnosed early, when treatments can be effective and before the sarcoma has spread to other parts of the body, but notes that it is vital that patients be referred to a specialist sarcoma team as early as possible; welcomes fundraising events in aid of cancer charities, such as Prog in the Park, which is returning to The Glen Pavilion in Dunfermline on 2 April 2022, the inaugural event of which was held in April 2019 in aid of Maggie's Fife and Sarcoma UK, and commends everyone involved for their tireless and sterling endeavours.
