***[S6M-00028](#) Paul O'Kane: International Day Against Homophobia, Biphobia and Transphobia 2021**—That the Parliament recognises the International Day Against Homophobia, Biphobia and Transphobia (IDAHOBIT); notes that it was founded 2004, is marked each year on 17 May and aims to raise awareness of violence and discrimination against LGBTQ+ people in order to drive positive change; notes that IDAHOBIT is celebrated in more than 130 countries; believes that it reminds everyone that there is still a long way to go until all LGBTQ+ people are free and safe from harm; acknowledges that reports from Stonewall Scotland suggest that one-in-five LGBTQ+ people have experienced a hate crime and that, often, these go unreported due to concerns that they will not be taken seriously by the authorities; recognises that, in many countries, LGBTQ+ people still live in fear for their livelihoods, families and lives, and acknowledges the need for an ongoing commitment to make positive change and advance the rights of LGBTQ+ people in Scotland and around the world.

***[S6M-00026](#) Liam Kerr: North East Sensory Services Receives £90,000 Trust Fund Award to Secure Employment for Blind and Deaf People**—That the Parliament congratulates North East Sensory Services (NESS) on receiving £18,000 over the next five years from the Robertson Trust to support what it sees as its sector-leading work in helping blind and deaf people find work, education and training opportunities and supporting people recently diagnosed with a sensory impairment to stay in employment; recognises that NESS, which was founded in 1879, currently supports around 6,500 people each year across Aberdeen, Aberdeenshire, Angus, Dundee and Moray, thanks to all the team at NESS for their hard work and dedication, and commends their efforts to break down barriers for people living with sensory loss.

ordnance that has been washed ashore at beaches across Dumfries and Galloway and for keeping the public safe from harm; notes that, most recently, on 15 May 2021, they attended an incident that involved the controlled explosion of a suspected Second World War torpedo and that, in February, they dealt with unexploded ordnance that was picked up in the net of a Dumfries and Galloway-based fishing boat; expresses concern regard the reported increase in these incidents over recent years, particularly due to the location of Beaufort's Dyke, which was the UK's largest offshore dump site for surplus conventional and chemical munitions after the war; notes that, according to the Public Record Office, approximately two tonnes of encased metal drums filled with radioactive laboratory waste were dumped there in the late 1950's; calls on the UK Government to carry out a risk assessment of the area and to disclose whether the site is routinely checked for safety; encourages the public to familiarise themselves with the guide to unexploded ordnance; notes that this can be found on the coastguard's website and social media pages; thanks the Coastguard, Royal Navy Bomb Disposal Team and all others involved in dealing with these incidents; hopes that they remain safe, and wishes them continued success.

***S6M-00023 Emma Harper: All Roads Lead to Whithorn Funding** —That the Parliament congratulates the community group, All Roads Lead to Whithorn, on securing a grant of £972,000, jointly from the South Scotland Enterprise Agency and the Scottish Government, to renovate the listed town hall; understands that this investment will be used to redevelop and extend the facility to establish a multi-activity community hub that will include a boxing gym, fitness suite and multi-function space with specialised equipment; believes that this will allow members of the community to participate in sports and physical activities that might otherwise have been inaccessible or unaffordable; notes that the funding means that the Braveheart's Boxing Club will have a permanent home to continue and enhance its work with young people; believes that this will help the club in providing role models and diversionary activities that could have a positive impact on those who might be struggling in education or with home life; notes that work has already commenced and the aim for it to be completed by autumn 2022, when it is anticipated that £100,000 worth of community and tourism benefits will be provided annually across Whithorn; congratulates all involved with achieving this funding, and wishes the project every success.

***S6M-00021 Kenneth Gibson: European Union Citizens are Welcome in Scotland**—That the Parliament understands that some EU citizens with job interviews are currently being sent to immigration removal centres and held in airport detention rooms across the UK, despite Home Office rules explicitly allowing non-visa holders to attend job interviews; acknowledges reports that among the people detained was a French citizen held at Edinburgh Airport for 48 hours; is concerned by the impact of the UK Government's "hostile environment" policy on the, mostly young, European citizens, who are believed to be being denied entry and detained; considers that this is an unacceptable situation; urges the UK Government to stop any refusal of EU nationals with job interviews entry at the border; recognises that European citizens have greatly enriched Scotland culturally and economically over recent decades, and reiterates its message that they remain welcome in Scotland.

***S6M-00020 Tom Arthur: PDA Day** —That the Parliament welcomes PDA Day 2021, which took place on 15 May; acknowledges that PDA (Pathological Demand Avoidance) is widely understood to be a profile on the autism spectrum; understands that this annual event is designed to increase understanding of PDA as a profile on the autism spectrum, manifesting in the avoidance of everyday demands, an anxiety-driven need to be in control, and the use of "social" strategies as part of this avoidance; notes that PDA can be difficult to diagnose because an individual's presentation may be quite different to what some people think autism "looks like", and accepts that, under the diagnosis of autism, a clear signpost to the PDA profile could improve outcomes for individuals and families.

For each Bill, the date of the next (or most recent) event in the Bill's passage is given. Other relevant information, e.g. about lodging amendments, is given in italics.

As soon as a Public Bill (i.e. a Government, Committee or Member's Bill) has completed Stage 1, amendments for consideration at Stage 2 may be lodged; and as soon as Stage 2 is completed, amendments for Stage 3 consideration may be lodged. The last lodging day for amendments at Stage 2 is four sitting days before the meeting at which those amendments will be considered (e.g. Wednesday for a meeting on Tuesday); at Stage 3 it is five days before. Amendments may be lodged until 4.30 pm on any sitting day, except on the last lodging day for each Stage, when the deadline is 12 noon.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.

European Charter of Local Self-Government (Incorporation) (Scotland) Bill (M)

Passed, 23 March 2021

The Bill has been referred to the Supreme Court under section 33 of the Scotland Act 1998 by the Attorney General and the Advocate General for Scotland.

UK Withdrawal from the European Union (Legal Continuity) (Scotland) Bill (G)

Passed, 21 March 2018

Following a reference under section 33 of the Scotland Act 1998 by the Attorney General and the Advocate General for Scotland, the Supreme Court has ruled that some provisions of the Bill are outwith the legislative competence of the Scottish Parliament. The Bill cannot be submitted for Royal Assent in its unamended form.

United Nations Convention on the Rights of the Child (Incorporation) (Scotland) Bill (G)

Passed, 16 March 2021

The Bill has been referred to the Supreme Court under section 33 of the Scotland Act 1998 by the Attorney General and the Advocate General for Scotland.
