### Members' Business motions that have achieved cross party support

**\*S6M-02070 Maggie Chapman: Transgender Day of Remembrance 2021**—That the Parliament recognises Transgender Day of Remembrance (TDoR) on 20 November 2021, a day, which is observed annually and internationally, to memorialise trans people lost to transphobia; understands that, while the murder of trans people for being trans in the UK is rare, suicide is not; further understands that more than one in four (27%) trans young people have attempted to take their own lives, and that nine in 10 (89%) have thought about it, with 72% having self-harmed at least once; believes that the current media climate has not helped; further believes that trans people need reassurance and support, and notes calls on members to show their solidarity and support for trans people.

**\*S6M-02098 Jackie Baillie: RCN Scotland Indicative Ballot Results** —That the Parliament notes the Royal College of Nursing (RCN) Scotland's report on its indicative ballot of NHS Scotland members to establish who would be willing to take some form of industrial action in support of their trade dispute on pay; understands that the ballot revealed that 90% of respondents would be willing to take industrial action, short of strike, while six out of 10 members said they would be willing to withdraw their labour in strike action; further understands that this ballot is a result of the fact that RCN members rejected the Scottish Government's single-year NHS pay offer

The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
