[S6M-02795](#) Jeremy Balfour: Welcoming the Down Syndrome Bill—That the Parliament welcomes the Down Syndrome Bill, introduced in the UK Parliament by Dr Liam Fox in June 2021; understands that it received cross-party support in the UK Parliament at its second reading in November 2021; welcomes what it considers the supportive comments made during the second reading from Douglas Chapman, the Scottish National Party MP for Dunfermline and West Fife; understands that, as introduced, the Bill extends to England and Wales, but that it could be extended further to apply to Scotland, and notes the calls on the Scottish Government to facilitate this opportunity to, it considers, improve the services offered to people with Down syndrome and to place a duty on local authorities and public bodies to assess the likely support needs, including education, health and social care, employment and independent living needs, of people with Down syndrome, and plan provision accordingly.

Motions for Debate

***[S6M-04051](#) Alex Cole-Hamilton: Economy: Ferries**—That the Parliament condemns the severe delays to the production of vessels 801 and 802 contracted by Scottish Government-owned Caledonian Maritime Assets Limited (CMAL), paid for by the Scottish Government, built originally by a company celebrated by the Scottish Government and, since 2019, by the nationalised Scottish Government-owned company; believes that these delays have left islanders and communities without reliable services that are critical to island life; notes that the Scottish Government’s Open Government Action Plan 2021-25 states that “an open government gives the public information about the decisions it makes, supports people to understand and influence those decisions, and values and encourages accountability (responsibility for those decisions)”; considers that the Scottish Government has breached each of its own tests of open government, to the cost of taxpayers and the islanders waiting year after year for the ferries that they need; notes the impact on their local economies and the impact of the cost overrun on the spending available for other public service priorities; expresses regret that no Scottish minister has either resigned nor considered resigning despite all of these events, and believes that if vessels 801 and 802 are not completed within the revised timescale and cost, as provided to Parliament on 23 March 2022, the latest in a string of revisions, then the ministers responsible deserve to finally be held to account in the form of resignations, and calls on the Scottish Government to give this assurance.

***[S6M-03958](#) Meghan Gallacher: EHRC Guidance for Separate and Single-sex Providers in Scotland, England and Wales** —That the Parliament welcomes the publication by the Equality and Human Rights Commission of what it believes is the much-anticipated guidance for separate and single-sex service providers in Scotland, England, and Wales; understands that this has been developed to provide guidance on the law to help organisations comply with their legal obligations; notes that the guidance states that the Equality Act 2010 allows for the provision of separate or single sex services in certain circumstances under “exceptions” relating to sex, and that, in order to establish a separate or single-sex service, providers must show that they “meet at least one of a number of statutory conditions ... and that limiting the service on the basis of sex is a proportionate means of achieving a legitimate aim”; further notes from the guidance that “a legitimate aim could be for reasons of privacy, decency, to prevent trauma or to ensure health and safety” and that providers must then be able to show that their action “is a proportionate way of achieving that aim”; notes that the guidance states that “there are circumstances where a lawfully-established separate or single-sex service provider can prevent, limit or modify trans people’s access to the service”, that this is allowed under the Equality Act, however, that “limiting or modifying access to, or excluding a trans person from, the separate or single-sex service of the gender in which they present might be unlawful” if providers “cannot show such action is a proportionate means of achieving a legitimate aim”, and that “this applies whether the person has a Gender Recognition Certificate or not”; further notes that the guidance states that, when considering how a service is provided to trans people, providers must “balance the impact on all service users and show that there is a sufficiently good reason for excluding trans people or limiting or modifying their access to the service”; acknowledges the view that some service providers may find it helpful to have a policy for how services are provided to trans people, and notes that, where this is the case, the guidance recommends that providers can develop a policy but states that this is not a legal requirement, and that if service providers do have a policy, then they “should be prepared to consider whether particular circumstances justify departing from the policy”.
