***S6M-04115 Clare Haughey: British Sign Language Bill - UK Legislation—**That the Parliament agrees that the relevant provisions of the British Sign Language Bill, introduced in the House of Commons on 16 June 2021, relating to the encouragement of the use of British Sign Language, so far as they fall within the legislative competence of the Scottish Parliament, should be considered by the UK Parliament.

***S6M-04108 Alexander Stewart: Dementia Awareness Week 2022—**That the Parliament acknowledges Dementia Awareness Week 2022; understands that, in Scotland, the event will run from 30 May to 5 June; acknowledges that the aim of the week is to continue the raising of awareness of dementia and to help improve the lives of people with dementia, their families and their carers; notes what it sees as the importance of acknowledging that dementia is not part of the natural ageing process, and that it affects the brain and makes it harder to remember things or think as clearly as before; understands that dementia is an umbrella term for over 100 different types of illnesses and disease symptoms, which may include memory loss, difficulties with day-to-day tasks, language difficulties and affected problem-solving ability, but that all the types of diseases are the same in that they damage brain cells and stop it working as well as it should; notes that Alzheimer Scotland provides information, support and dementia-friendly activities to help ensure that nobody faces dementia alone; is concerned that dementia can affect every area of human thinking, feeling and behaviour, but that each person with dementia is different in how the illness affects them, depending on which area of their brain is damaged; understands that over 90,000 people in Scotland have dementia, including many in the Mid Scotland and Fife region, and that it is most common in older people but can affect people in their 40s and 50s, or even younger; acknowledges that the causes of dementia are not fully understood; highlights what it sees as the importance of the researchers all over the world who are working hard to understand the causes of dementia and develop treatments, and acknowledges what it considers the importance of initiatives such as Alzheimer Scotland's "Tea & Blether" mornings during Dementia Awareness

***S6M-04040 Rachael Hamilton: Decline of Iconic Scottish Species**—That the Parliament recognises what it sees as the concerning decline of iconic Scottish species; understands that there has been a marked reduction in many species of bird across Scotland, namely in populations of capercaillie, ptarmigan, lapwing and curlews; recognises the latest report by a sub-group of the NatureScot Scientific Advisory Committee, *Review of Capercaillie Conservation and Management*, which it understands advises that, if perilous population declines continue, the species could be lost to Scotland within two to three decades; notes the view that additional predator control is required, and further notes the calls on the Scottish Government to ensure that the action points from the review are taken and that land managers, including those in the Ettrick, Roxburgh and Berwickshire constituency, are able to properly control predators in order to save iconic bird species.

***S6M-04035 Katy Clark: Supporting Peace in Colombia**—That the Parliament welcomes the reported commitments made by senior trade union leaders across the UK, including in the West Scotland region, to continue with their unwavering support for the Colombia peace agreement; understands that the signing of the agreement in Havana in 2016 came after decades of civil war left 220,000 citizens dead and millions displaced or disappeared; further understands that the agreement creates a framework for political and land reform, the incorporation of the Revolutionary Armed Forces of Colombia (FARC) as a political party, a transitional justice system, peace courts and other restorative justice approaches; recognises what it sees as the proactive and positive role that UK and Irish trade unions have played supporting the work of the NGO, Justice for Colombia (JFC), which it understands has facilitated a series of visits to the country by union leaders and activists to promote dialogue, learning and cooperation; notes JFC's reported role in helping bring political leaders from Northern Ireland and South Africa to Colombia to share their experience of implementing peace agreements in their respective lands; is concerned that, in recent years, the peace process has reportedly stalled, with increasing reports of human rights abuses, political violence and the murder of trade unionists and environmentalist and indigenous activists, which it understands has seen over 1,000 people killed since the agreement was signed; notes the calls on all candidates in the forthcoming presidential election in Colombia to commit to implementing the peace agreement in full, and further notes the calls on the Scottish and UK governments to do all that they can to promote peace in Colombia.

***S6M-03997 Katy Clark: College Workers Dispute**—That the Parliament notes reports that members of the EIS Further Education Lecturers' Association (EIS-FELA) have voted for strike action; understands that 80% of UNISON members at Scotland's colleges have also voted to move to a strike ballot, including at colleges in the West Scotland region; further understands that Colleges Scotland has put forward a consolidated award of £850, as well as a £150 one-off payment to express gratitude for staff efforts during the COVID-19 pandemic, and that this constitutes a real-terms decrease in pay; believes that industrial relations in the sector have deteriorated to an unacceptable level; understands that, since 2014, there have been disputes around equal pay, common conditions of service, transfer to permanent status for staff on insecure contracts, annual pay agreements, so-called fire and rehire policies, and discipline and grievance procedures and policies; notes the view that the colleges sector in Scotland has been underfunded, with Colleges Scotland reportedly estimating a real-terms reduction in the college budget of £51.9 million for 2022-23; further notes the view that the Scottish Government should

come forward with a financial rescue package to support the sector; believes that real-terms cuts mean that college budgets are not keeping pace with staffing costs, and that real-terms staff pay is not keeping pace with inflation amidst a cost of living crisis; acknowledges what it sees as the extraordinary work of college staff during the pandemic, which it understands has included delivering both online and on-campus services to students, and notes the calls on the Scottish Government to intervene and ensure that all college staff are awarded a real-terms increase in pay for 2022-23.
