## Members' Business motions that have not achieved cross party support

\*S6M-03136 Michelle Thomson: International Women's Day 2022: Break the Bias—That the Parliament recognises 8 March 2022 as International Women's Day (IWD); acknowledges what it sees as the social, economic, cultural and political achievements of women through history and around the world; understands that the theme of IWD 2022 is #BreakTheBias, which aims to highlight the impact of bias, both conscious and unconscious, on women and girls and to imagine a world free of bias, stereotype and discrimination; notes the view that it is important for MSPs to reaffirm a commitment to upholding the fundamental human rights of women and girls, while working together to accelerate gender parity in society; further notes the view that it is crucial for influential organisations to reject discrimination and abuse in society and within their own communities, while committing to be positive role models, and notes the calls to collaborate and unite behind the principles of IWD 2022, to ensure equity, diversity and inclusivity, and to break down barriers and forge women's equality in communities in Scotland and across the world.

\*S6M-03116 Paul McLennan: National Social Prescribing Day, 10 March 2022—That the Parliament notes National Social Prescribing Day on 10 March 2022, and celebrates what it sees as the creation, implementation and success of the Scottish Social Prescribing Network (SSPN); understands that the SSPN was created in June 2020 as no such network existed in Scotland: believes that social prescribing is best described as a means of enabling health professionals to refer people to a range of local, non-clinical services; understands that social prescribing is an approach that is based on the view that people's health and wellbeing are determined mostly by a range of social, economic and environmental factors, and that it seeks to address people's needs in a holistic way; considers that, as a result of the COVID-19 pandemic, social prescribing programmes stepped up and rapidly adapted, using what it sees as innovative approaches to support people in their communities; understands that this was done through a range of means, using community connectors, social prescribers and community link workers; notes that the SSPN facilitated a session on 30 September 2021, which, it understands, was targeted at key policy makers, and involved representatives from the Scottish Government, public health, academia and the third sector, and that a report from the session is available with a number of recommendations; believes that SSPN is an important movement; understands that it was established from a grassroots level; notes the view that the SSPN should continue to grow and develop and that it is essential to a national approach to achieving Scottish Government policies and strategies, and

further notes the view that the Scottish Government should be involved in the network, in order to assess where it fits in terms of policy areas.

#### Other new and altered motions and amendments

\*S6M-03189 Monica Lennon: St Andrew's High School in Coatbridge Launches its Pupil Parliament —That the Parliament congratulates St Andrew's High School in Coatbridge, North Lanarkshire, on the launch of its Pupil Parliament; notes that the inaugural meeting of the Pupil Parliament was held on 28 January 2022, chaired by the school captains, Sophie Hamill and Krystian Tomasiewicz; commends pupils for their leadership and active participation; recognises what it sees as the important support and role of school staff, including teachers Mrs Lowry and Mr O'Donnell; understands that the school is working towards UNICEF's Gold Award for Rights Respecting Schools, and wishes everyone supporting this endeavour, and the important work of the Pupil Parliament, all the best for the future.

\*S6M-03187 Sharon Dowey: In Memory of Alex Ingram—That the Parliament notes with great sadness the passing of Ayr United FC's Alex Ingram; believes that Alex transformed Ayr United, as it quickly became a leading part-time club in Scotland after his signing; understands that Alex was known for his bravery and was known as tough competition to his opponents; acknowledges that Alex was Ayr United's leading scorer in its promotion-winning season of 1968-69; understands that he had a close affinity with supporters, and extends sincere condolences to his family and friends.

\*S6M-03186 Fiona Hyslop: Marking International Women and Girls in Science Day - 11 February 2022—That the Parliament recognises what it sees as the importance of gender equality in the Science, Technology, Engineering, Maths (STEM) disciplines; further recognises what it sees as the importance of supporting and promoting women and girls in science, not only as beneficiaries, but also as agents of change, which, it believes, promotes equality, diversity and inclusion; notes reports that women are typically given smaller research grants than male colleagues; understands that, while they reportedly represent 33.3% of all researchers worldwide, only 12% of members of national science academies are women; highlights what it sees as the important work taking place internationally through UNESCO, to break down what it considers is the gender bias in science, and commends what it sees as the successes of local STEM groups across the country, who are promoting and championing women and girls in science.

\*S6M-03184 Graeme Dey: Sustainable Kirriemuir Secures £160,000 of National Lottery Funding—That the Parliament congratulates Angus community environmental organisation, Sustainable Kirriemuir, on securing £160,000 of National Lottery funding, £10,000 via the Together for Our Planet initiative and £150,000 through the Community Led fund over the next two years; understands that this will enable the group to retain its three members of staff and continue work on its Future Kirrie Climate Action Plan, developed by local residents with support from Keep Scotland Beautiful, while connecting people to nature and to each other, and enhancing local climate literacy across all ages; further understands that plans include helping 100 people from the local area to grow their own food, rolling out a growing award across Angus, developing a seed cooperative and tree-growing collective, training 10 people to deliver community cooking sessions, working with other local groups, schools and Angus Council on fostering active travel, supporting individuals and workplaces with energy efficiency, promoting reuse and repair through a fashion

and needlework group, running a series of events and workshops from April 2022 with the establishment of a community resilience network, and launching a green map of Kirriemuir linking all projects; commends Sustainable Kirriemuir on its highly laudable aims and ambitions with this work, and considers that it is having a positive impact on the local area and on the wellbeing of residents.

\*S6M-03182 Jenni Minto: New Marine Science Labs at Dunstaffnage—That the Parliament welcomes the new facilities and opportunities that, it understands, have been created at Malin House, on the European Marine Science Park, following a £2 million investment by Highlands and Islands Enterprise; understands that five companies, Patogen AS, Tritonia Scientific Ltd, Ocean Ecology, Oceanium, and Shetland firm, Ocean Kinetics, have expanded into the new laboratories and offices; believes that the European Marine Science Park is a world-class facility, situated on the stunning Dunstaffnage peninsula in Argyll and Bute; considers that, in the context of what it sees as the global climate emergency, researchers at the Scottish Association of Marine Science, and commercial firms at the European Marine Science Park, are playing a key role in preserving and protecting the marine environment, and promoting sustainable economic activity, so that the marine environment can be used for the benefit of people without degrading its health and productivity; notes that preparatory work is under way to develop three more buildings, and wishes the European Marine Science Park continued success for the future.

\*S6M-03180 Kaukab Stewart: Scotland's Renewable Energy Industry - Supply Chain Impact Statement 2021—That the Parliament welcomes the publication of Scotland's Renewable Energy Industry - Supply Chain Impact Statement 2021, A Snapshot, by Scottish Renewables, which, it understands, highlights 32 suppliers working across renewable energy technologies; recognises the companies and organisations which, it believes, are utilising their expertise, skills and capabilities to work towards delivering what it sees as a just transition to renewable energy; acknowledges the range of supply-chain projects that are taking place across the country; commends what it sees as the world-leading innovation that is happening across the renewable energy supply chain, and welcomes what it sees as the strength of Scotland's renewable energy supply chain sector, and the economic, environmental and social benefits that it brings to communities across the country.

\*S6M-03178 Clare Adamson: Neighbourhood Networks 20th Anniversary—That the Parliament congratulates the charity, Neighbourhood Networks, on its 20th anniversary; notes that there are currently 28 networks across central Scotland, with four in Motherwell and Wishaw; understands that the networks support vulnerable adults with learning disabilities, disabled people, and those experiencing poor mental health, and help enable people to live an independent life, safely, within their own homes and be fully involved within their communities; further understands that, over the years, Neighbourhood Networks has hosted many visitors from abroad, who have been interested in the work of the organisation, including from Australia, the Czech Republic, Slovakia, the Netherlands, New Zealand and, more recently, Finland; believes that this has allowed the Neighbourhood Network to become a global peer support network; understands that the anniversary celebrations will include its first online conference, from 29 to 31 March 2022, on the subject of Networks as Agents of Change - Together Anything is Possible, and that it will highlight the developing peer-support networks across the central belt, and wishes it all the best with the celebrations and for the future.
