Peebles Men's Shed and conducted a number of workshops with members to inform the storyline, which was written and developed over two years; further understands that it explores the myth that men do not talk, in a fictional Men's Shed setting, discussing such issues as loneliness, alcoholism and recovery, loss of a life partner, caring for a partner with dementia, post-traumatic stress disorder (PTSD) from previous service in the Armed Forces, and where the next supply of jaffa cakes is coming from; notes that this was made possible by funding from the Peebles-based charity, Inspiring Life - Evie Douglas Memorial Fund, which was set up by Freda Douglas in memory of her daughter Evie; congratulates those involved, on the play coming to fruition in January 2022, with a rehearsed reading at The Eastgate Theatre in Peebles, employing a professional cast of three actors and the services of one local amateur, who helped with the stage direction, in front of an audience of over 70 people; believes that projects such as this celebrate community collaboration and are an important part of raising awareness of issues around mental health, particularly among those in society who may be less comfortable in engaging in conventional support for this, and considers that organisations such as Men's Sheds are a vital support for many in Scotland's communities.

Members' Business motions that have achieved cross party support

*S6M-04844 Christine Grahame: The Role of the Open University—That the Parliament notes what it sees as the important contribution of the Open University (OU) to education in Scotland; understands that there were 22,000 OU students in Scotland in 2020-21, with students in every Scottish Parliament constituency and every local authority area, including 395 in Midlothian South, Tweeddale and Lauderdale, as well as almost half a million informal learners, making the OU the fourth largest university in Scotland; further understands that the OU works collaboratively with businesses, local authorities, the NHS, social care, the third sector and trade unions to provide skills through multiple programmes; considers the OU and its flexible learning model as particularly important in widening access to education, as shown by statistics demonstrating that, of OU students, 23% live in rural or remote areas, 20% join undergraduate programmes without standard university entrance qualifications, and 24% declare a disability, with the average age of students being 28, and with as many students recruited from the most deprived areas as the least deprived; believes that the OU plays a vital role in providing access to education for those who may not wish to, or be able to, undertake traditional models of study, subsequently improving their career prospects and providing much needed skills in the workforce, particularly in STEM subjects, which 40% of OU students from Scotland are studying, and congratulates all involved at OU, both student and staff, in making it the institution it is today.

*S6M-05033 Christine Grahame: World Elder Abuse Awareness Day—That the Parliament notes that World Elder Abuse Awareness Day falls on 15 June 2002, and aims to raise awareness about elder abuse and how to reduce it; further notes that the World Health Organization states that one in six people aged over the age of 60 experienced some form of abuse in community settings during the past year, with rates increasing since the COVID-19 pandemic; understands that an estimated 2.7 million people a year in the UK are affected by the abuse of older people; believes that there is little awareness of the extent of this issue amongst the general population,

*S6M-05020 Jackie Dunbar: Green Freeport for North East Scotland—That the Parliament welcomes that, on 10 June 2022, a major regional alliance announced its formal bid for green freeport status, which reportedly has the potential to boost Gross Value Added income (GVA) by £7.5 billion over the next decade and usher in a new era of investment, innovation, regional regeneration and opportunities for those that need them most across North East Scotland; understands that the bid, which could bring 30,000 high skilled, high paid jobs to the north east, encompasses Aberdeen City and Peterhead, and is being taken forward jointly by Aberdeen International Airport, Port of Aberdeen, Peterhead Port Authority and Aberdeen City and Aberdeenshire councils; believes that, should the bid be successful, it could ensure that North East Scotland, and in particular Aberdeen Donside, becomes the global epicentre of the energy transition to lead the world in creating carbon-free energy and the technology needed to achieve net zero, through bringing large-scale, advanced manufacturing to Aberdeen to maximise economic benefit from what it sees as Scotland's rapidly-growing offshore wind and hydrogen sectors, as well as to accelerate pioneering carbon capture projects; further believes that this exciting potential will also create a regional customs hub for premium and globally recognised Scottish food and drink exports, building direct links to key markets for products such as Scotch whisky, seafood and meat produce; encourages the Scottish and UK governments to look favourably at the joint bid, which it considers could bring huge benefit to communities across Aberdeen, and the wider North East Scotland, and wishes the bid every success as it moves forward for consideration.

*S6M-04852 Gillian Mackay: Parkinson's UK 66-mile Challenge in Falkirk —That the Parliament congratulates those who took part in Parkinson's UK 66-mile challenge at the Kelpies in Falkirk on 9 June 2022, and others across the country; acknowledges that the money raised will help to fund the vital work and research undertaken by Parkinson's UK; understands that over 12 thousand people are estimated to take part in walks across Scotland between July and October, and that the challenge is open to individuals or groups of all ages and abilities; celebrates what it sees as the important and ongoing impact that the work of Parkinson's UK has made to people's lives since its inception in 1969; thanks all the staff and volunteers who have contributed to fighting Parkinson's, and wishes the organisation continued success.

*S6M-04850 Sharon Dowey: UK Government's Programme on Future of Agriculture in Rwanda—That the Parliament recognises what it sees as the UK Government's efforts in Rwanda to sustainably increase agricultural productivity and benefit poor farming households through greater commercialisation of Rwandan agriculture; believes that this will result in a greater contribution of agriculture to economic growth, food security, and poverty reduction; notes that the programme ran from January 2019 to March 2022 with a projected budget of £28.8 million, which has been fully spent; commends what it sees as the UK Government's efforts in Rwanda, and applauds to the success of this programme and to everyone involved.

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
