[S6M-05097](#) Marie McNair: Action Mesothelioma Day 2022—That the Parliament recognises that 1 July 2022 is Action Mesothelioma Day; notes that the action day aims to raise awareness of the disease, which it understands is caused by breathing in asbestos fibres; further understands that there are approximately 2,700 new mesothelioma cases in the UK every year, including over 200 in Scotland, which is the highest number in Europe, and that there are at least a further 2,000 cases of lung cancer that are likely to be caused by asbestos exposure; notes that the action day brings to light the extraordinary work of support groups across Scotland that continue to support people impacted by mesothelioma and their families, as well as doing work to remember those who have died as a result of mesothelioma; acknowledges the particular contribution of Clydebank Asbestos Group, as it approaches its 30th anniversary, which has provided information and support to people with asbestos-related conditions for decades; wishes Action Mesothelioma Day every success, and notes the view that there is a continued need for research into the management and treatment of this condition.

[S6M-04364](#) Michael Marra: Dundee Drugs Commission Review Report—That the Parliament welcomes the publication of the report, *Time for Kindness, Compassion and Hope: The Need for Action Two Years On*, by the Dundee Drugs Commission; thanks the Commission for its work in the production of both of its reports; is grateful to everyone who brought witness and testimony to this work from lived experience and frontline service provision; believes that testimony will have been incredibly difficult to deliver for many of the witnesses; understands that, despite the urgent recommendations in the first report, Dundee continues to have a very high level of drugs deaths by national and international comparisons; notes with concern what it sees as the failure to sufficiently progress the recommendations of the original report by all agencies in Dundee; further notes support for the recommendations of the Commission, which include an urgent health needs assessment for drug users, the wholesale reform of substance misuse, and recovery services that move away from a punitive medicalised model to a community facing system of care; is concerned by the report's conclusion that "the scale of the challenge to turn the situation around hasn't been fully appreciated" by local leadership, and notes the calls for the full adoption of the recommendations with a specific delivery plan from the Dundee Partnership.

***[S6M-05082](#) Rhoda Grant: Fair Tax Week**—That the Parliament notes that Fair Tax Week took place from 11 to 19 June 2022 and that the week celebrates companies and organisations that hold the Fair Tax Mark, which certifies that the company or organisation pays the correct level of tax in the correct jurisdiction at the correct time; understands that many companies and organisations in the Highlands and Islands, including the Co-op Party, the Co-operative Group, Scotmid Co-op, SSE and Scottish Water, have already received the Fair Tax Mark; acknowledges the results of recent polling, which reportedly found that 66% of people believe that governments and local authorities should at least consider a company's ethics and how it pays its tax; notes the calls on local authorities in Scotland to consider signing the Councils for Fair Tax Declaration, and further notes the calls on the UK Government, Scottish Government and local government to look at ways of incorporating the Fair Tax Mark into public procurement processes in order to ensure that public funds go to companies that pay their way.

***[S6M-04978](#) Jamie Greene: Ayrshire Bus Services**—That the Parliament recognises what it sees as the importance of lifeline bus services to communities in Ayrshire and across wider Scotland; expresses serious concern at the latest reported announcement by Stagecoach that the X34 and X36 will no longer operate from 17 July 2022; notes the calls on the Scottish Government to work constructively with Stagecoach on the reinstating of the X34 and X36 services in full; understands that commuters and passengers travelling to and from Ayrshire are already frustrated by the reported 28% reduction in ScotRail services that took place earlier in 2022; thanks bus operators and bus drivers for their work during the COVID-19 pandemic and beyond to keep vital services running, and the day-to-day role that they play throughout Scotland and further afield, and considers that buses play a crucial role in reducing carbon emissions, helping achieve net zero and lowering congestion, which reportedly costs Scotland £2 billion a year.

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
