*[S6M-03597](#) **Joe FitzPatrick: Ending Conversion Practices**—That the Parliament notes the Equalities, Human Rights and Civil Justice Committee's 1st Report, 2022, (Session 6), *Report on Petition PE1817: End Conversion Therapy* (SP Paper 88).

Members' Business motions that have not achieved cross party support

*[S6M-03609](#) **Ross Greer: Industrial Relations in the College Sector**—That the Parliament is concerned by the record of industrial relations in the college sector over the last decade; understands that nationwide industrial action by lecturers has taken place in six of the last eight years, largely due to the perceived failure to implement previous agreements on pay, conditions and status; further understands that one such example of industrial action was the "fire and rehire" incident at Forth Valley College in 2021, which, it believes, became the catalyst for a national strike and resulted in the affected lecturers being reinstated to their previous positions; notes with regret reports that the nationally agreed disputes resolution process is not yet in place at all colleges; believes that staff feel their extensive efforts to support students throughout the COVID-19 pandemic have not been recognised and that this, in combination with frustration over pay awards to senior management, has left many feeling demotivated; recognises what it sees as the pivotal role played by college teaching and support staff throughout the pandemic, and believes that colleges, including those in the West of Scotland, have a critical role to play in Scotland's economic recovery from COVID-19, efforts to tackle the climate emergency, and the eradication of child poverty.

*[S6M-03254](#) **Clare Adamson: Fairtrade Fortnight 2022**—That the Parliament marks Fairtrade Fortnight 2022; understands that Fairtrade Fortnight is an annual initiative, coordinated by the Fairtrade Foundation, which aims to raise awareness of Fairtrade products and encourage a societal shift in the way that people consume in order to improve the lives of farmers and producers; further understands that Fairtrade Fortnight sees thousands of individuals, companies and groups come together to share the stories of the people who produce the food that people eat, mine the minerals that people use, and grow the materials for people's clothes, and highlight that these roles are often underpaid and rife with exploitation; understands that the first Fairtrade

Fortnight took place in Scotland, directed by Barnaby Miln, and campaigned to get every supermarket in Scotland to stock Fairtrade products, and that the initiative is now celebrated internationally; acknowledges what it sees as the importance of the Fairtrade standards, which are designed to tackle poverty and empower producers, which include economic criteria such as a minimum pricing safety net, environmental criteria such as emphasising ecologically and agriculturally sound practices and the promotion of organic production, and social criteria such as requirements for democratic self-organisation, collective bargaining, fair employment practices, women's empowerment and prohibitions on forced and child labour; believes that, by learning about how everyone is connected through the things that people eat, drink and wear, everyone is better equipped to shape a more compassionate and sustainable world, and wishes everyone involved with Fairtrade Fortnight every success.

***[S6M-03556](#) Rona Mackay: National Lottery Community Fund Support for Groups in Strathkelvin and Bearsden**—That the Parliament congratulates seven organisations based in the Strathkelvin and Bearsden constituency on securing support through the National Lottery Community Fund in the most recent round of awards; understands that a total of £195,724 was received following successful applications from seven local organisations; commends GRACE (Group Recovery Aftercare Community Enterprise) for its track record of using a varied selection of engaging activities and classes to entice people out of isolation and back into their community; applauds the Kirkintilloch Men's Shed as a safe space for anyone to come and focus on the creation of functional items in a sociable way; thanks the Sunshine Wishes Children's Charity for their work in supporting families with children who have life-limiting illnesses or a physical or learning disability; understands that Twechar Community Action can now hire a youth and family worker to support youth activities taking place at their centre; applauds the ongoing work of Families of Auchinairn Coming Together (FACT) in encouraging social interaction and wellbeing through crafting classes for local adults; is grateful for the ongoing provision by Rookie Rockstars of the counselling service, known as Rookie Minds, for young people experiencing poor mental health; commends the planning by Bishopbriggs Community Council to install lights in Auchinairn's main shopping area, and sends its very best wishes and thanks to all who give their time, energy and experience in supporting these groups to have impact in Strathkelvin and Bearsden.

***[S6M-03550](#) Rhoda Grant: Inverness College UHI Launches Free Breakfast Club**—That the Parliament notes the launch of a free breakfast club for students by Inverness College UHI in response to what it sees as the poverty crisis faced by students; understands that this is one of only a handful of college breakfast clubs in Scotland; believes that this is one of several "share the warmth" initiatives at Inverness College UHI, which includes a donation scheme to support students in need of clothing and toiletries and a "pay it forward" scheme in its canteen; considers that this will benefit students most in need in their education, and calls on the Scottish Government to do more to support Scotland's students through the cost of living crisis.

***[S6M-03549](#) Donald Cameron: Celebrating the Inaugural World Gaelic Week**—That the Parliament welcomes the inaugural World Gaelic Week, which will take place between 21 to 27 March 2022; understands that World Gaelic Week has been pioneered by broadcaster and musician Joy Dunlop, who is Director of Seachdain na Gàidhlig; recognises that the week-long series of cultural events was inspired by similar campaigns in Ireland and Cape Breton and also followed on from the success of #SayAGaelicPhraseDay during lockdown, and wishes both the organisers and participants of World Gaelic Week every success in its first year and beyond.
