Scotland's Local and Regional Economies—That the Parliament recognises the huge potential of Community Wealth Building as a practical, place-based economic development model that can help transform local and regional economies to deliver a Wellbeing Economy for Scotland; agrees that Community Wealth Building can deliver more and better jobs, business growth, community-owned assets and shorter supply chains supporting net zero ambitions; welcomes the progress made by public, private and third sectors in implementing Community Wealth Building in Scotland so far; notes that the 2021 Programme for Government and recent National Strategy for Economic Transformation confirmed plans to introduce legislation on Community Wealth Building during the current Parliamentary session; believes that this provides an important opportunity to think creatively and innovatively about the interconnections and interdependencies between the economy, environment and society, and supports plans for wide engagement on this legislation.

equivalent levels of solar technology deployment; considers that a number of policy matters within the control of the Scottish Government, including permitted development rights and business rates, could help the sector grow significantly; recognises what it sees as the ability of solar energy systems to work as a good companion to wind to make more effective, efficient use of the electricity grid and storage network; considers that, due to reported projections for solar to be the UK's cheapest form of energy this decade, and to have the unique capability to be deployed at all scales, solar is vital to supporting an affordable energy mix, and a just transition, and notes the calls on the Scottish Government to urgently assess the potential for a 2030 solar deployment target of a minimum of 4GW, and accompanying policy changes to embrace and enable this low-cost mature technology, to help tackle the climate emergency and provide investment and jobs in communities up and down the country, including in the Inverness and Nairn constituency.

#### **Motions for Debate**

\*S6M-04621 Ben Macpherson: Update on Delivery of Social Security Benefits—That the Parliament agrees that social security is a human right and an investment in people; welcomes the introduction and delivery of 12 Scottish social security benefits in total, seven of which are new forms of support only available in Scotland, including most recently the Scotlish Child Payment, Child Disability Payment and Adult Disability Payment; notes the more humane and compassionate process for applying for the Adult Disability Payment, which contrasts with the intrusive assessments often required to receive Personal Independence Payment from the UK Government; further notes the implementation of a clinically determined definition of "terminal illness" and fast-tracking of these applications for support; welcomes the introduction of indefinite awards within Scottish disability assistance, which provides the most severely disabled people with long-term financial security; looks forward to the introduction of new benefits, including Low Income Winter Heating Assistance and Scottish Carer's Assistance; notes that social security is one of the three key pillars in the national mission to tackle child poverty, and commends the extension of the Scottish Child Payment to under-16s and plans to increase it to £25 per week per child by the end of the year; welcomes the substantial financial support that these benefits provide to people, which is important at all times and particularly so now as people are impacted by the cost of living crisis in the UK, and acknowledges the Scottish Government's record investment of £3.9 billon in benefit expenditure in 2022-23, which is £360 million above that received by the UK Government, all of which will provide meaningful social security support to over one million people, including low-income families and households, disabled people and carers.

# **Members' Bills Proposals**

#### **Proposals for Members' Bills**

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
