*S6M-04407 Pam Gosal: Congratulating Scottish Universities on Research Excellence Framework 2021 Results—That the Parliament acknowledges the results of the 2021 Research Excellence Framework, which it understands states that 84.86% of the research submitted by Scottish universities is considered "world-leading" or "internationally excellent" in its quality; considers that Scotland is a world-leading research nation; recognises what it sees as the contribution that this research has made to social and economic challenges faced in the UK, including in the West Scotland region, and abroad; welcomes the reported growth and investment arising from this world-class research, and considers that Scotland should capitalise on what it sees as the massive potential created by Scottish universities to improve sustainable economic growth.

Members' Business motions that have not achieved cross party support

*S6M-04574 John Mason: Scotland in the Red—That the Parliament acknowledges the report, Scotland in the Red, published by Step Change Debt Charity Scotland; understands that the report looked at personal debt statistics in Scotland during 2021; considers that, given the harsh economic situation throughout the COVID-19 pandemic, coupled with the ongoing cost of living crisis and inflation at its highest rate in 40 years, citizens' personal finances are being squeezed, including those in the Glasgow Shettleston constituency; understands that Step Change has seen a rise in the proportion of clients in the private rental sector, with over 60% of all clients now renting their homes; further understands that the proportion of Step Change clients in a vulnerable situation, in addition to their financial difficulty, has increased sharply to a new high of 54%; understands that Step Change clients' average arrears on essential bills has increased by £659 to £2,961; further understands that nearly two-thirds of vulnerable clients were female, that 52% were at risk of losing their home, and 75% were in arrears with electricity bills before the full impact of recent price rises; notes that council tax remains the most prevalent household bill with which clients are struggling, with 44% of vulnerable clients in arrears; thanks Step Change for

what it sees as this enlightening report into the struggle faced by many constituents across the country, and commends Step Change for what it considers its ongoing vital work.

*S6M-04479 Katy Clark: Moorpark Place Care Home—That the Parliament notes with concern reports that the Active Care Group has moved to derecognise the trade union agreement in place with GMB Scotland at Moorpark Place care home in Kilbirnie, North Ayrshire; further notes the view that Active Care Group has failed to engage with workers or union representatives about these changes; understands that the matter has been referred to the UK Government's Advisory, Conciliation and Arbitration Service; considers that trade union recognition at care homes is vital to ensuring workers' rights issues are raised, collective grievances are heard and conditions are improved in the sector; understands that Active Care Group is owned by Montreux Capital Management, an investment firm incorporated in the Cayman Islands; notes with concern data from Registers of Scotland, which reportedly shows that at least 44 Scottish care homes were owned by companies based in tax havens at the end of 2019; believes that the Scottish Government's proposed National Care Service is an opportunity to reform social care, embed fair work standards in the sector and ensure ethical procurement practices are put in place, and notes the calls on the Scottish Government to include commitments in its national commissioning and procurement structure of standards and processes that state that no care home contract will be awarded to companies that fail to recognise trade unions or apply union-negotiated rates of pay, or that are owned offshore.

*S6M-04591 Colin Beattie: The Warblers Receive £4,520 from National Lottery Awards for All Scotland—That the Parliament congratulates The Warblers on receiving a £4,520 grant from National Lottery Awards for All Scotland; notes that The Warblers cover both East Lothian and Midlothian; understands that The Warblers are a singing group for people with lung conditions, focused on improving lung health among their members; recognises that the group extended its remit to support those experiencing breathlessness due to long COVID; appreciates that this funding will allow the group to continue supporting people with chronic respiratory conditions and long COVID in East Lothian and Midlothian, and praises The Warblers for all their work.

*S6M-04590 Colin Beattie: Play Therapy Base Receives £119,382 from Medium Grants Scotland—That the Parliament congratulates Play Therapy Base, which is based in Dalkeith, on receiving a £119,382 grant from Medium Grants Scotland: Improving Lives; understands that this group not only supports families in Midlothian but also Edinburgh, East Lothian and the Borders; recognises that this funding will be used to support 50 children and families by providing one-to-one play therapy sessions and filial therapy sessions, and will support children and parents presenting with distress and anxiety; acknowledges how important these local services are for families, and especially young children who are facing challenging circumstances; thanks Play Therapy Base for its work, and wishes it the best going forward.

*S6M-04589 Colin Beattie: Changes Receives £139,316 from Medium Grants Scotland—That the Parliament congratulates Changes, which is based in East Lothian, on receiving a £139,316 grant from Medium Grants Scotland: Improving Lives; understands that the group will use this funding to set up a befriending project to reduce isolation and loneliness and improve mental health and wellbeing; notes that this project will include one-to-one and group befriending opportunities and a monthly conversation café, and that participants will be able to draw on

*S6M-04588 Liam Kerr: Elasmogen Receives £8 Million Investment—That the Parliament congratulates Elasmogen for receiving an £8 million boost to help with what it sees as its pioneering research; notes that Elasmogen is a life science company based in Aberdeen, which, it understands, is currently developing drugs based on antibody-like molecules from sharks; understands that its soloMER binders are helping to create the next generation of biologics for inflammatory, autoimmune diseases and oncology, and reportedly have the potential to significantly improve the health of people in Scotland; applauds the work they are undertaking; understands that the biologics being developed are believed to be 10 times more effective than existing therapies for conditions including some cancers, rheumatoid arthritis and inflammatory bowel disease, and wishes all involved with what it sees as this ground-breaking work at Elasmogen all the best for the future.

*S6M-04586 Pam Gosal: The Queen's Platinum Jubilee Legacy Project Installed in Milngavie—That the Parliament congratulates the P7 class of Craigdhu Primary School, along with Glasgow Clyde College and Milngavie in Bloom, on their involvement in creating and installing what it sees as a magnificent 3D crown outside the Fraser Centre in Milngavie in honour of The Queen's Platinum Jubilee, and understands that the legacy project involved local children in designing and creating a patriotic flower bed with the assistance of volunteer gardeners and teachers.

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
