S6M-03023 Colin Smyth: Ethical Principles in Wildlife Management—That the Parliament notes reports that thousands of animals and birds are taken and killed in wildlife management operations every year, including in the South Scotland region; considers that these are sentient beings that are capable of experiencing pain and suffering; notes the view that Scotland should lead the way in sustainable and humane interaction with the wild animals in the environment; notes the belief that wildlife management should be governed by ethical principles, such as the international consensus principles for ethical wildlife control, which recommend that efforts to control wildlife should, wherever possible: alter the human practices that cause human-wildlife conflict and develop a culture of coexistence, be justified by evidence that significant harms are being caused to people, property, livelihoods, ecosystems, and/or other animals, have measurable outcome-based objectives that are clear, achievable, monitored, and adaptive, minimise animal welfare harms and be confined to the fewest number of animals, be informed by community values as well as scientific, technical, and practical information, be integrated into plans for systematic long-term management, and be based on the specifics of the situation rather than negative labels such as "pest" or "overabundant", and notes the view that there are opportunities to integrate ethical principles into the Scottish Government's strategic approach to wildlife management and its species licensing review. **R**

***[S6M-04562](#) Stephanie Callaghan: University of Glasgow ARC to be Opened by Nobel Prize Winner, Professor David MacMillan**—That the Parliament welcomes the announcement that the University of Glasgow's Mazumdar-Shaw Advanced Research Centre (ARC) will be officially opened by alumnus David MacMillan on 8 June 2022; recognises that David, a current Princeton University professor, was a winner of the Nobel Prize in chemistry in 2021, alongside Benjamin List, for his work developing organocatalysis; notes that the opening ceremony will celebrate that the ARC is officially open and provide an opportunity to thank donors and supporters; further notes that the ARC has been named after the University of Glasgow graduate, John Shaw, and Kiran Mazumdar-Shaw, who gifted \$7.5 million to the university in July 2019, and that it is hoped that they will make the journey to Glasgow to attend the opening themselves; believes that the ARC will help facilitate collaboration across disciplines, allowing colleagues from different research areas to share space and meet people with new ideas and interests, and understands that, following on from the official opening in June, the ARC launch festival, ARCADIA, will run from 16 to 30 September 2022.

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
