[S6M-05292](#) **Stephen Kerr: A Potato With More Vitamin C Than a Lemon**—That the Parliament believes that gene-editing technology is game-changing for food production; understands that there is a big difference between gene-modification and gene-editing; further understands that gene-editing makes small, specific changes to existing DNA, or removes a section altogether, speeding up a process that could occur through natural breeding; recognises that scientists at the James Hutton Institute in Dundee have reportedly predicted that gene-editing technology could result in potatoes with more vitamin C than lemons being grown, and considers that Scotland could be left behind England in food production due to Scottish legislation prohibiting the use of gene-editing in Scotland.

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
