<u>S6M-05911</u> Emma Roddick: Mental Health Stigma in the Workplace—That the Parliament is concerned by what it sees as continued stigmatisation of mental health issues and those who experience them; considers that, while wider understanding of depression and anxiety is progressing, organisations such as the Royal College of Psychiatrists have noted a pervasive stigma relating to personality, dissociative, and psychosis-related disorders; understands that this stigma is particularly concentrated in the world of work, meaning that people with psychiatric conditions are less likely to be employed or remain so; notes efforts such as SeeMe Scotland's See Me in Work scheme, which aim to support employers to tackle mental health discrimination; understands that a survey by SeeMe was explored in a recent report, *Mental* Health – Exploring the Current Landscape, published by Centred, a mental health charity based in the Highlands of Scotland, which showed around half of people believe someone would not disclose a mental illness at work for fear of adverse effects on their employment; considers that this report contains valuable research around stigma, rural mental health, and the overall situation in Scotland; further notes the belief that this demonstrates that more work needs to be done by employers, public health agencies and government to tackle mental health stigma, and notes the calls for these issues to be addressed in the new Scottish Government Mental Health Strategy.

## \*S6M-06610 Fulton MacGregor: Programme Promoting the Benefits of Shared

Parenting—That the Parliament notes what it sees as the importance of the involvement of both parents when bringing up a child; asserts that every child of separated parents deserves the love and support of both of their parents; believes in the need for parents to co-operate where appropriate; understands that research has shown that there is a lack of support for children of separated parents; considers that parents, including in the Coatbridge and Chryston constituency, may need help to make important decisions about sharing the care of their children; acknowledges the view that there is a need for public policy to recognise these challenges; praises Shared Parenting Scotland for piloting the New Ways for Families programme; recognises that the online programme focuses on the key skills of emotion management, flexible thinking and behaviour moderation; applauds the ethos of the programme, which, it considers, puts children first, as well as focusing on improving co-parenting and making decisions together out of court; notes reports that a similar programme introduced in Canada saw a significant increase in parenting co-operation upon completion, and congratulates Shared Parenting Scotland for securing £16,500 worth of funding from the Scottish Government, The National Lottery, and an anonymous trust in order to deliver the programme.

\*S6M-06711 George Adam on behalf of the Parliamentary Bureau: Approval of SSI—That the Parliament agrees that the Social Security (Miscellaneous Amendment and Transitional Provision) (Scotland) Regulations 2022 [draft] be approved.

\*S6M-06707 Annie Wells: Former Archbishop of Glasgow Mario Conti dies—That the Parliament pays tribute to The Emeritus Archbishop of Glasgow, Archbishop Mario Conti, who passed away on 8 November 2022; understands that Archbishop Conti died peacefully after a short illness at the Queen Elizabeth University Hospital in Glasgow; notes that Archbishop Emeritus Mario Conti had been a priest for 64 years and a bishop for 45 years; understands that he trained at St Mary's College in Blairs, Aberdeenshire, before studying at the Scots College and Pontifical Gregorian University in Rome, where he obtained degrees in philosophy and theology, and that he was later ordained a priest in Rome on 26 October 1958; notes that, after a series of roles, including his only parish priest appointment to Wick and Thurso, Scotland's most northerly mainland Catholic parishes, he was named Bishop of Aberdeen in February 1977; understands that he was one of the last surviving bishops in the world to have been appointed by Pope (now saint) Paul VI; further understands that, after 25 years in Aberdeen as bishop, he was named as successor to Cardinal Tom Winning as Archbishop of Glasgow in 2002, and served in that role for 10 years, and believes that the death of Archbishop Mario will be felt not just in the Archdiocese of Glasgow, but across Scotland and beyond.

\*S6M-06705 Tess White: Hollie Davidson Selected to Referee Women's Rugby World Cup Final —That the Parliament congratulates Aboyne-based Scottish Rugby Union referee, Hollie Davidson, on being selected to referee the delayed Women's Rugby World Cup 2021 final; notes that the final between hosts New Zealand and England will take place at Eden Park in Auckland on 12 November 2022; understands that Hollie will become the first female official to take charge of Rugby World Cup Finals in both Rugby Sevens format and the traditional 15-a-side format, following on from achieving the milestone of becoming the first woman to referee a men's Six Nations side in a test match when Italy faced Portugal in June 2022; notes that Hollie, who attended Aboyne Academy, became Scottish Rugby Union's first full-time professional women's referee in 2017; understands that, in January 2021, Hollie refereed her first professional men's game, when she took charge of Newcastle Falcons v Castres in the Challenge Cup, and wishes Hollie, her team of officials, and both teams the very best of luck for the final.

## **Proposals for Members' Bills**

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
