Members' Business motions that have not achieved cross party support

*S6M-06659 Rhoda Grant: Tackling Gender-based Violence—That the Parliament welcomes the Global 16 Days Campaign, which is due to begin on 25 November 2022; notes that this campaign is an annual international campaign, started by activists at the inaugural Women's Global Leadership Institute in 1991, and continues to be coordinated each year by the Center for Women's Global Leadership; understands that the 16-day campaign is used as an organising strategy by individuals and organisations around the world to call for the prevention and elimination of violence against women and girls, including domestic violence and commercial sexual exploitation; highlights what it sees as the urgent need for any measures that target and tackle issues of violence affecting women and girls, and welcomes the events that are planned in Scotland to support the campaign, including events for frontline workers to raise awareness of trauma-informed practice for women who sell or exchange sex, a webinar on the influence of pornography in shaping attitudes and beliefs towards women, and in-depth discussions for relevant organisations on commercial sexual exploitation.

*S6M-06638 Jim Fairlie: Impact of Not Uprating Means Tested Benefits in Line with Inflation in 2023-24—That the Parliament is concerned by the findings of a Joseph Rowntree Foundation (JRF) report, published on 12 October 2022, highlighting the potential impact across UK parliamentary constituencies if the UK Government chooses not to uprate means tested benefits in line with inflation in 2023-24; understands that 22% of working-age families receive means tested benefits in the Perth and Kinross Council area, and that this is a concern across all Scottish local authority areas; further understands that the 6% increase in line with earnings, reportedly being considered by the UK Government, does not take into account inflation and would subject these constituents to a real-terms decrease in income; notes the point made by JRF that "politicians should think long and hard about the impact of withholding hundreds of pounds from thousands of families in their constituencies when the basic rate of benefits is already at its lowest in real terms for 40 years and prices are sky-high", and believes that the ongoing and deepening cost of living crisis will be felt by many people across every constituency in Scotland and that it will have its greatest impact on the most vulnerable.

*<u>S6M-06733</u> Michelle Thomson: NHS Forth Valley Wins Award for Trauma-informed Cervical Screening Project—That the Parliament congratulates NHS Forth Valley on winning the Care for Mental Health Award at the Scottish Health Awards 2022; understands that this was awarded for the development of a trauma-informed cervical screening project, which was implemented by the dedicated staff from NHS Forth Valley the Meadows and the psychological therapies team; understands that the trauma-informed cervical screening project has been developed to meet the needs of vulnerable women across Forth Valley by removing barriers through an understanding of trauma to facilitate access to what it sees as such essential screening for women, who have lived experience of sexual trauma; further understands that this service aims to be sensitive and responsive to identify those who may need such additional support to increase uptake of cervical screening, improve the experience of women, avoid re-traumatisation and to identify any health changes early enough to improve outcomes for women; recognises the contribution of Resilience Learning Partnership towards the development of this project, ensuring, it understands, that the voice of women with lived experience of such trauma fed into the process throughout; congratulates all those involved with the development and implementation of a trauma-informed cervical screening project from NHS Forth Valley and Resilience Learning Partnership for their well-deserved award, and wishes them well for the future.

*S6M-06731 Natalie Don: Barsail Primary School, Erskine—That the Parliament congratulates all the pupils and staff at Barsail Primary School in Erskine for what it sees as their glowing inspection report from Education Scotland; notes that the inspection team from Education Scotland visited the school in September 2022 and met with parents, carers and children and worked closely with the headteacher and staff, and further notes that the school achieved an evaluation of Very Good in all four quality indicators used by Education Scotland.

*S6M-06728 Carol Mochan: Trussell Trust Warns of Tsunami of Need for Food Banks this Winter —That the Parliament notes with concern the reported worrying rise in the need for food banks in the South of Scotland region and across Scotland, and the Trussell Trust warning of a "tsunami of need" for food banks as the cost of living crisis escalates; further notes that the Trussell Trust's latest food parcel figures for Scotland, released on 10 November 2022, show a 34% increase in emergency food parcels distributed from April to September 2022 compared to 2021; understands that the same six-month period represents the busiest ever on record for the Trussell Trust's network in Scotland; further understands that, during the same period, there has been a significant rise in the number of parcels distributed to families with children, with 40,000 distributed, and in the numbers of people using food banks who have never used one before, which reached 27,000, and that one in five people needing to use a food bank are in work; recognises what it sees as the tremendous work being done by food bank staff, volunteers and trustees across Scotland to support people in crisis, and looks forward to the delivery of Scotland's action plan to end the need for food banks.

Proposals for Members' Bills

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.

For each Bill, the date of the next (or most recent) event in the Bill's passage is given. Other relevant information, e.g. about lodging amendments, is given in italics.

As soon as a Public Bill (i.e. a Government, Committee or Member's Bill) has completed Stage 1, amendments for consideration at Stage 2 may be lodged; and as soon as Stage 2 is completed, amendments for Stage 3 consideration may be lodged. The last lodging day for amendments at Stage 2 is four sitting days before the meeting at which those amendments will be considered (e.g. Wednesday for a meeting on Tuesday); at Stage 3 it is five days before. Amendments may be lodged until 4.30 pm on any sitting day, except on the last lodging day for each Stage, when the deadline is 12 noon.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
