Napier University and Robert Gordon University represented by UNISON, which include cleaners, administrators and library, catering and security workers, most recently took strike action on 3 and 4 October; understands that the Universities and Colleges Employers Association's (UCEA) final offer of 3%, or 7.2% for the lowest paid workers, is sub-inflationary as the current CPI rate is 9.9% and the current RPI rate is 12.3%; considers that UCEA's offer has been imposed on university staff despite being subject to a live dispute with the trade unions, and that such impositions also occurred in 2021 and 2020; understands that the trade unions, University and College Union, Educational Institute of Scotland-University Lecturers' Association and Unite, are at varying stages of consulting or balloting their members for action in the same dispute; believes that industrial relations in the sector have deteriorated to an unacceptable level; notes the view that the staff do incredible work and deserve to be recognised fairly and paid properly; further notes the belief that the Scottish Government must urge universities and UCEA to take meaningful steps to negotiate a fair resolution to these disputes, and notes the calls on universities and UCEA to return to the negotiating table in the interests of workers and students.

\*S6M-06798 Donald Cameron: Willie McCallum Breaks Piping Record—That the Parliament congratulates Willie McCallum of Campbeltown on being named the overall champion of the prestigious Glenfiddich Piping Championship; understands that Willie competed against nine of the world's greatest solo bagpipers in the renowned 49th annual competition at Blair Castle; recognises that this marks a record ninth win for Willie, extending his pre-existing record for having the most overall wins ever; acknowledges the importance of piping in Scottish culture, and hopes that this victory will inspire more people into piping.

# **Members' Bills Proposals**

## **Proposals for Members' Bills**

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.

The last lodging day for amendments at Stage 2 is four sitting days before the meeting at which those amendments will be considered (e.g. Wednesday for a meeting on Tuesday); at Stage 3 it is five days before. Amendments may be lodged until 4.30 pm on any sitting day, except on the last lodging day for each Stage, when the deadline is 12 noon.

A Hybrid Bill is subject to the same rules except in the case of Stage 2 where amendments for consideration may be lodged no earlier than the completion of any consideration of evidence at Stage 2.

Amendments to Private Bills are subject to different deadlines. These are set out in Rule 9A.12 of Standing Orders.

Members are advised to lodge amendments in good time before the beginning of a Stage and as early as possible during the day.
