***[S6M-06755](#) Pam Duncan-Glancy: UNISON Year of Disabled Workers 2022**—That the Parliament celebrates UNISON and its recognition of 2022 as the Year of Disabled Workers; understands that UNISON is using these 12 months to promote disability in the workplace by highlighting the experiences of its disabled members as well as the value and insight that they bring to the union and workplace; notes that, with 200,000 disabled members, UNISON calls for a greater enforcement of legal rights, including the fundamental right to reasonable adjustments at work; recognises that the main aims of the Year of Disabled Workers include raising awareness of the social model of disability and the importance of changes to the workplace and working practices, explaining the implications of the disability pay gap as well as how it may be addressed, increasing members' confidence to self-define as disabled, and increasing the number of disabled activists in the union, and thanks UNISON for its continued representation of disabled workers, including in the Glasgow region. R

Other new and altered motions and amendments

***[S6M-06851](#) Rona Mackay: Impact of Cost of Living Crisis on Victims of Domestic Abuse**—That Parliament recognises that 25 November 2022, which is International Day for the Elimination of Violence Against Women, marks the first day of the annual global campaign 16 Days of Activism against Gender-based Violence, ending on 10 December; applauds the work of organisations, including Scottish Women's Aid, in emphasising what it understands is the impact of the current cost of living crisis in placing more women and children at risk of domestic abuse, commercial sexual exploitation, rape and sexual assault; understands that women's poverty is one of the critical enabling conditions for perpetration of these crimes; considers that the cost of living crisis exacerbates what it sees as the already often impossible choice for women between leaving and facing homelessness and destitution, or staying with an abuser; believes that the soaring cost of living, against the backdrop of what it sees as a decade of stagnant wages, an inadequate social security safety net and the disproportionate impact of COVID-19 on women is creating a nightmare storm; applauds Scottish Women's Aid on what it sees as its tireless efforts to support women and ensure that the needs of women and children experiencing domestic abuse are not forgotten in response to this cost of living crisis; notes that the global theme for the 2022 campaign

is "UNITE! Activism to end violence against women and girls", which calls for worldwide actions to increase awareness, galvanise advocacy efforts and share knowledge and innovations; believes that gender-based violence is widespread in Scotland, and considers that it can and must be prevented through societal change.

***[S6M-06850](#) Sarah Boyack: Qatar Human Rights Abuses**—That the Parliament expresses its concern regarding the reported human rights abuses by the Qatari authorities, which, it considers, have gone unchecked by FIFA as the World Cup 2022 begins on 20 November 2022; welcomes the publication of *Human Rights Guide for Reporters: 2022 FIFA World Cup in Qatar*, by the Human Rights Watch; considers that there are serious concerns over workers' rights and the number of migrant worker deaths; further considers that there is very little data available on the number of migrant deaths, with the International Labour Organization (ILO) reporting that there were 50 work-related deaths in 2020 alone; notes the serious concerns regarding LGBT people who have reportedly been subjected to physical and sexual assault and harassment at the hands of the Qatari authorities; understands that women are heavily discriminated against in Qatar, with their freedoms strictly curtailed, and calls on FIFA to take human and workers' rights seriously for this and future tournaments.

***[S6M-06843](#) Evelyn Tweed: 16 Days of Activism Against Gender-based Violence**—That the Parliament recognises 16 Days of Activism Against Gender-based Violence; understands that the 16 Days of Activism against Gender-based Violence against women and girls is an international civil society-led campaign that takes place each year from 25 November, the International Day for the Elimination of Violence against Women, to 10 December, Human Rights Day; believes that gender-based violence is both a symptom and a cause of gender inequality; considers that violence against women is the most pervasive breach of human rights worldwide; understands that those facing multiple forms of discrimination experience disproportionate gender-based violence, including members of the LGBTQ community, disabled women, and women of colour; recognises the work being done by organisations and individuals in Stirling and throughout Scotland to tackle gender-based violence and gender inequality, and believes that work is still required by everyone to make change and ensure communities are safe for everyone.

***[S6M-06837](#) Annie Wells: New Exhibition Celebrating 50 Years of Printmaking at Glasgow Print Studio**—That the Parliament recognises that a new exhibition celebrating 50 years of printmaking at Glasgow Print Studio is set to open at Kelvingrove Art Gallery and Museum on 18 November 2022; understands that the exhibition, *The Love of Print*, will showcase artworks created by celebrated Scottish artists in the five decades since the studio was formed in 1972; notes that *The Love of Print* will bring together over 225 significant prints by 130 artists, which, it understands, collectively embodies a "who's who" of Scottish art over the last 50 years; believes that Glasgow Print Studio has an international reputation as a major contributor to contemporary printmaking and that, with facilities amongst the most sophisticated in Europe, it attracts artists from all over the world and provides a unique environment where famous names work alongside students and members, and acknowledges that each artist who is featured in *The Love of Print* has gifted a print that will be accessioned into Glasgow Museums Collection.

***S6M-06823 Maggie Chapman: International Day for the Elimination of Violence Against Women 2022**—That the Parliament recognises the International Day for the Elimination of Violence Against Women on 25 November 2022, a day that is observed annually and internationally to raise awareness that women and girls are disproportionately subjected to domestic, sexual, and other forms of violence; understands that, where gender information was recorded, four in five (80%) incidents of domestic abuse in 2020-21 involved a female victim and a male accused; further understands that sexual crimes, towards all genders but disproportionately towards women and girls, account for 5% of all crimes recorded in Scotland in 2021-22, and that such crimes increased by 15% compared to 2020-21, from 13,131 to 15,049; understands that these crimes are now at the highest level seen since 1971, the first year for which comparable groups are available; commends all those set to take part in the 16 Days of Activism against Gender-based Violence, from 25 November to 10 December 2022; considers that organisations such as Rape Crisis Scotland, Grampian Rape Crisis, Scottish Women's Aid, Engender, Dundee International Women's Centre, and many others, should be commended for their work, which assists and supports all women and girls; believes that all elected representatives should support their efforts, in particular men, and considers that the fight for an inclusive feminist world continues.

***S6M-06809 Maurice Golden: Impact of Fuel Poverty on the Health of Citizens and General Practice**—That the Parliament recognises what it considers the direct connection between tackling fuel poverty, improving public health, and lessening the demand on general practice and cost to the wider NHS; agrees that the winter period ahead stands to be very challenging for many, but believes that it could be devastating for those in fuel poverty; acknowledges reports from GP members of the Royal College of General Practitioners (RCGP) Scotland who, it understands, are already working to levels of demand and under staffing pressures never before experienced; understands that cold homes can impact on asthma, respiratory infections, hypertension, mental health, dementia, heart attack and stroke risk, and childhood development; welcomes what it considers as the robust reports on this from the Academy of Medical Sciences, the Royal Society, the Faculty for Public Health, the Institute for Health Equity, and the Health Foundation; recognises findings from the Scottish House Condition Survey 2019 that show that north east Scotland has areas of above-average fuel poverty rates, including Dundee City and Perth and Kinross, as well as areas with more households with a low energy efficiency rating, such as Angus; notes with interest the research that found that for each 1°C drop below 5°C external temperature, presentations to general practice increase by up to 19%, and recognises the call from RCGP Scotland to seize the health co-benefits of tackling fuel poverty with a more holistic approach.

***S6M-06808 Sandesh Gulhane: Global Excellence Ranking for City of Glasgow College**—That the Parliament congratulates City of Glasgow College on receiving a Global Award for Excellence at the 2022 European Foundation for Quality Management (EFQM) Awards in Lyon, securing a 7-Diamond world ranking, the highest level of recognition and, it understands, the best

Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
