\*S6M-06414 Michelle Thomson: Small Business Saturday 2022—That the Parliament recognises what it sees as the importance of the Small Business Saturday initiative that is taking place across Scotland and other parts of the UK, on 3 December 2022; understands that Small Business Saturday aims to promote the work of small businesses, highlight their positive impact on their communities throughout the course of the COVID-19 pandemic and cost of living crisis. and encourage people to shop local and recognise the value of small businesses within their communities across Scotland; notes that Small Business Saturday involves support for a range of SMEs, including self-run companies, family businesses, local community stores, small manufacturers, wholesalers, business services and online stores; further notes figures from the Scottish Parliament SPICe briefing, Scotland's Business Base: Facts and Figures, showing that, in 2020, sole proprietors, owner-manager or employee director companies, mainly in the arts or education fields, accounted for 70% of the 364,310 private sector enterprises in Scotland and contributed 14% of employment in Scotland, and small businesses employing up to 49 employees accounted for 28% of all private sector enterprises and 29% of total employment in Scotland; considers that these figures show that the majority of enterprises in Scotland are small businesses: understands that the Small Business Saturday initiative is a grassroots campaign. which is in its 10th year and is sponsored in its efforts by American Express; congratulates the initiative on the work that it has done to support and recognise small businesses thus far, looks forward to the initiative's continued success in the future during what it sees as these uncertain and challenging times, and appreciates the work done across Scotland, including in the Falkirk East constituency, to support local small businesses.

\*S6M-06401 Karen Adam: Rerailing Scotland—That the Parliament recognises what it sees as the vital role that Scotland's railways will fulfil in the low-carbon economy; considers that inclusive growth and access to high-quality public transport are transformative for people and businesses; understands that Peterhead and Fraserburgh are the two largest towns in Scotland that are cut-off from rail connectivity; notes the view that rail links could lead to substantial investment and the regeneration of the towns; believes that the ports located in the towns are strategically crucial for future trade routes with Scotland's Nordic and European neighbours; notes reports of the vast economic potential that freight trains would bring to the local, regional and national economy, and

\*S6M-06368 Stephanie Callaghan: Circular Fashion: Looping the Thread—That the Parliament encourages the adoption of circular fashion methods that ensure clothing is produced in a more considered way that closes the loop on production, including responsible manufacturing, use, and the end-of-life stage, emphasising the value of utilising a garment right to the end; understands that, over the past decades, the production and consumption of clothing has increased exponentially around the world leading to a dramatic increase in the negative social and environmental consequences; notes that a report by Zero Waste Scotland, which assessed the carbon impact of Scotland's household waste, showed that textiles account for nearly a third of emissions even though they only make up 4% of waste by weight; further notes that Scotland is home to what it understands is the UK's leading circular fashion hub, Advanced Clothing Solutions (ACS), offering fashion brands and retailers a carbon neutral, rental and resale fulfilment service from a developing biodiversity area in Holytown, North Lanarkshire; welcomes the Scottish Government's £2 million Circular Textiles Fund, as well as the £18 million Circular Economy Investment Fund, administered by Zero Waste Scotland, offering investment for SMEs based in Scotland and supporting work that will deliver circular economy growth; considers that there is need for transparency in the fashion supply chain; notes the calls for legislation that helps to achieve fair pay for textile and garment workers around the world, in light of reports that modern slavery runs deep within the industry, and further notes the growing calls to incentivise responsible and circular consumption through fiscal and regulatory levers that reward fashion companies that design products with lower environmental impacts and penalise those that do not.

\*S6M-06359 Paul McLennan: Celebrating St Andrews Day—That the Parliament believes that St Andrew's Day should be an opportunity for all the people of Scotland to celebrate their patron saint, cultural diversity and membership of the international community; considers that there should be wider recognition of a holiday, including a school holiday, on or around 30 November so that St Andrew's Day becomes a day of national celebration; believes that people should be encouraged to follow what it sees as St Andrew's example, with acts of kindness especially to less fortunate people, with the aim of creating a more caring, compassionate society; notes that St Andrew is also the patron saint of several other countries, including Ukraine and Russia; condemns Russia's invasion of Ukraine, and calls for a peaceful and just solution to the ongoing conflict in that part of the world. R

\*S6M-06302 Emma Harper: Transforming Scotland's Vacant and Derelict Sites —That the Parliament notes with concern reports that Scotland has almost 9,500 hectares of vacant and derelict urban land, and that just over one quarter of Scotland's 5.4 million population is estimated to live within 500 metres of a derelict site, with this percentage increasing in communities on the Scotlish Index of Multiple Deprivation (SIMD); believes that Scotland's stock of vacant and derelict land is a legacy of the nation's industrial past, with many of these sites, including across the South Scotland Region, such as the George Hotel in Stranraer, former Interfloor Factory in Dumfries, Central Hotel in Annan and N Peal Building in Hawick, being in their derelict condition for many years; notes research, including from the Scotlish Land Commission, University of Glasgow and

Green Space Scotland, which shows that vacant and derelict sites can harm the wellbeing of communities, with findings reportedly showing that these sites can contribute to poor mental health, feelings of a lack of safety, anxiety and a persistent low mood; further notes reported concerns from communities around the traceability of the ownership of vacant and derelict sites, which, it understands, are often owned by absentee landlords and corporations as part of property and financial portfolios; considers that Scotland has a huge potential to lead the UK in transforming these sites into useful community assets; notes the view that focussing on these sites as a vehicle for delivery could help to enhance policy coordination across civic Scotland by concentrating effort and resources where they are most needed to benefit communities; welcomes the Scottish Land Commissions report, Transforming Scotland's Approach to Vacant and Derelict Land, Recommendations from the Vacant and Derelict Land Taskforce; notes calls on the Scottish Government to set out its progress towards implementing these recommendations, and to outline its engagement with the Scottish Land Commission's joint Vacant and Derelict Land Taskforce; further notes what it sees as the role of communities, as, it understands, has been seen in Heathhall, Dumfries and Galloway, in calling on Dumfries and Galloway Council to address the former Interfloor Factory, and notes the view that communities across Scotland should become involved in taking transformative action to ensure these sites dealt with as a priority.
