***[S6M-05762](#) Rhoda Grant: Specialist Neurological Nursing Posts**—That the Parliament is concerned by the reported decision of NHS Western Isles to remove the posts of Epilepsy and MS specialist nurse; understands that concerns have been expressed about the long-term future of the Parkinson's specialist nurse post; notes reports that the NHS board intends to replace these posts with a more generalist advanced neurology nursing post; further notes reports that the NHS board proposes to increase the scope of the nursing post to cover more neurological conditions; considers that this would represent a real terms cut to the service with fewer nursing hours dedicated to supporting more people; notes the view that in a cost of living crisis it is imperative to ensure patients have access to as much care and treatment locally as possible; recognises that there is no on-island neurologists or specialist support and that people with neurological conditions have to travel to NHS Greater Glasgow and Clyde for face-to-face appointments; understands that NHS Greater Glasgow and Clyde does not intend to increase its support to the islands in the wake of this reported cut to specialist nursing provision; recognises what it sees as the importance of the specialist nursing posts in this context and based on the testimony from people living with epilepsy, MS and Parkinson's on the Islands; understands that this decision was reportedly taken without any consultation with local neurological communities or the national charities that initially helped to fund the posts; further understands that local and national groups have expressed concern that such a cut to specialist nursing provision has the potential to put the safety of those in the local community affected by neurological conditions in jeopardy, and notes the calls from local groups, including Neuro Hebrides, Parkinson's Western Isles and national stakeholders, including Epilepsy Scotland, MS Society Scotland and Parkinson's UK Scotland, for NHS Western Isles to work collaboratively with them and people affected by neurological conditions in the Western Isles to deliver a comprehensive service that meets the needs of all stakeholders.

***[S6M-05725](#) Maurice Golden: Sustainable Fashion Week 2022**—That the Parliament marks Sustainable Fashion Week 2022, which will run from 16 to 25 September 2022, and the opportunity it offers to recognise what it sees as the long-standing efforts of businesses, charities and community groups throughout Scotland to promote sustainable textiles and fashion; notes

reports of the disproportionately high environmental impact of discarded textiles in Scotland compared with other materials; further notes the reported potential global impacts of fast fashion that is imported to Scotland through extended supply chains, including poor working conditions and negative outcomes for the natural environment; believes that a circular economic model offers the best opportunity to reduce those impacts through increased reuse of clothing and new business models of leasing and renting, whilst developing sustainable manufacturing using native fibres; further believes that such a model would encourage rural wealth creation through enhanced opportunities for fibre producers, such as wool farmers, and the network of makers using traditional skills, such as weaving and knitting, to support high quality manufacturing, and notes the calls to encourage stakeholders to build on existing best practice to establish Scotland as a global leader in sustainable textiles.

***[S6M-05607](#) Stuart McMillan: Greenock and Inverclyde Faced with Higher Forecourt Prices that Rest of Scotland**—That the Parliament rejects what it sees as the unfair fuel-pricing policy reportedly facing the people of Greenock and Inverclyde; understands that reports from BBC Scotland and the *Greenock Telegraph* suggest that forecourt prices in the area are significantly higher than in other parts of Scotland, including in more rural constituencies; believes that fuel retailers operating in Inverclyde have failed to acknowledge the impact of what it sees as a localised approach to pricing on people and businesses in the area, which, based on the Scottish Index of Multiple Deprivation (SIMD), ranks highest in Scotland for levels of deprivation; welcomes the announcement that the Competition and Markets Authority (CMA) will conduct a market study into the supply of road fuel in the UK; notes the view that changes are needed to prevent fuel retailers from charging significantly higher prices in one area compared to nearby locations; believes that reducing reliance on petrol and diesel vehicles is crucial, in light of the climate emergency; considers, however, that some people rely on their car for work or health reasons, and that purchasing a hybrid or electric vehicle, or using public transport, is not always an option; highlights what it sees as the vast profits being made by big businesses, including oil and gas companies; believes that this is in sharp contradiction to the cost of living crisis facing society that is plunging more households into poverty; notes the view that the UK Government must extend measures to help households, including through a cut in VAT and reduction in fuel duty; further notes the calls on the UK Government to act immediately, before autumn and winter 2022; notes the view that, if immediate action is not taken, the oil and gas sector in Scotland will carry a disproportionate burden of funding a UK-wide response to the cost of living crisis; notes calls on fuel retailers to reduce forecourt prices in Greenock and Inverclyde so that they are in line with the rest of Scotland, and looks forward to the CMA's report into the supply of road fuel across the UK being published later in 2022.

***[S6M-05778](#) Elena Whitham: Challenge Poverty Week 2022**—That the Parliament recognises Challenge Poverty Week 2022, which runs from 3 to 9 October; notes that activities, events and actions are taking place across Scotland aimed at highlighting the realities of, and solutions to, poverty, as well as increasing public support for tackling poverty; understands that over one million people in Scotland are living in poverty and that the cost of living crisis is pushing even more into hardship; notes the view that governments, politicians, civil society and communities all have a role to play in solving poverty; understands that particular groups of people, including low-paid women, lone parents, disabled people and people from black and minority ethnic backgrounds, are disproportionately more likely to experience poverty; notes the view that poverty in Scotland can and must be solved, by boosting incomes and reducing the cost of living; considers that people in Scotland believe in compassion and justice, and support action to end poverty, and celebrates the work undertaken by organisations and communities across Scotland to stem the rising tide of poverty.

***[S6M-05814](#) Jackie Baillie: Vale FC Wins the Pan-disability Scottish Cup**—That the Parliament congratulates Vale FC on winning the Pan-disability Scottish Cup; notes that the pan-disability football team was formed by Alan Skelton, who now coaches the side, and school friends, Connor McFall and Cameron Bonner, in 2012, while they were pupils at the Vale of Leven Academy; acknowledges that they took home their first ever Pan-disability Scottish Cup, beating Dalkeith Thistle 1-0 in the final in Falkirk, on 14 August 2022; recognises that the team gives people with a range of disabilities the chance to get involved in sport and make friends at the same time, and wishes them every success in the future.
