That the Parliament recognises what it sees as the vital role of community-led housing in tackling what it considers is the rural and island housing crisis, and in supporting those communities towards a sustainable future; believes that there are diverse and significant challenges facing rural and island communities in providing housing and the varied implications this has for sustaining the rural population; recognises what it considers as the enabling role of community housing trusts and organisations, such as South of Scotland Community Housing, Communities Housing Trust and Rural Housing Scotland, which support communities through what it understands can be a burdensome and long process; notes the belief that more can be done to facilitate community-led housing and remove barriers to locally-based projects; further notes the view that there is a need to support community-led affordable housing as a priority, and that the upcoming Land Reform and Community Wealth Building bills have the potential to do so; congratulates those organisations that have accomplished community housing projects and utilised available funds, such as the Rural and Island Housing Fund; considers that there is a need to learn from these organisations and continually improve, and congratulates what it sees as trailblazing projects that

*S6M-08336 Katy Clark: UK Parliament's BEIS Committee Report into Royal Mail—That the Parliament notes the publication of the UK Parliament's Business, Energy and Industrial Strategy (BEIS) Committee's report, *Royal Mail*, which found that the company is failing to meet some of its statutory obligations under the Universal Service Obligation (USO); considers that the USO is a vital public service, which guarantees the delivery of letters six days a week for many communities across Scotland, including in the West of Scotland region; acknowledges the concerns of the BEIS Committee that Royal Mail has deprioritised the delivery of letters as a matter of company policy over recent years; notes that the BEIS Committee also highlights in its report that the blanket approach by Royal Mail in not paying sick pay during periods of strike action will have been unduly harsh on those who were genuinely unfit for work; further notes the BEIS Committee's calls for Ofcom to undertake an enforcement investigation into Royal Mail's delivery of the USO, and notes the calls for the Scottish Government to ensure that Royal Mail is adhering to fair work principles, given that the company holds a substantial public contract to provide postal services for all Scottish public sector organisations.

Passed, 23 March 2021

Following a reference under section 33 of the Scotland Act 1998 by the Attorney General and the Advocate General for Scotland, the Supreme Court has ruled that some provisions of the Bill are outwith the legislative competence of the Scottish Parliament. The Bill cannot be submitted for Royal Assent in its unamended form.
