[S6M-07477](#) Fergus Ewing: Holocaust Memorial Day 2023—That the Parliament recognises what it sees as the importance of continuing to impart the lessons of the Holocaust to each generation; considers that the Holocaust was the systematic attempt by a genocidal regime in Europe to murder all Jewish people on the continent between the years 1941 and 1945, with six million men, women and children tragically losing their lives; notes that the annual Holocaust Memorial Day will be held on 27 January 2023, and that the chosen theme for this year's event is "ordinary people"; recognises that this particular theme has been chosen to highlight the ordinary people who were involved in all elements of, not just the Holocaust, but later genocides including in Cambodia, Rwanda, Bosnia and Darfur; acknowledges that, to better understand ordinary people, the theme has been subdivided into five categories: perpetrators, bystanders, rescuers, witnesses and crucially, victims; further acknowledges that, according to the theme, particular groups of people do not always belong to just one of the categories, with railway workers cited as an example where some in this job at the time of the Holocaust are considered as perpetrators, for driving trains to concentration camps, and others as rescuers, for hiding Jewish people; understands that the theme can be widened to include ordinary locations and sites, including schools and hospitals, as such buildings can be used to perpetrate genocide; notes that the theme also highlights that there are extraordinary individuals in all genocides, including those who were part of what it considers remarkable efforts to rescue and save the lives of people targeted by murderous regimes, and believes that underpinning the theme is the powerful narrative that everyone living today is an ordinary person, who is able to be extraordinary in their actions through making the choice to challenge prejudice, stand up against hatred, and speak out against identity-based persecution.

***[S6M-07622](#) David Torrance: Alex James Colquhoun Elected as Vice President of the European Showman's Union**—That the Parliament congratulates Alex James Colquhoun after being elected as the Vice President of the European Showman's Union; understands that Alex James was elected to the position of vice president after what it sees as his tireless efforts in assisting and working to improve the lives of showpeople in Scotland with fundamental issues, most recently through the provision of funding during the COVID-19 pandemic; further understands that Alex James is also the current chairman of the Scottish Section of The Showman's Guild and that he brings a wealth of knowledge to his new role; believes that Alex James has been instrumental in the return, since the pandemic, of Burntisland's Summer Fair and Kirkcaldy's Links Market, which was established in 1304 and is Europe's longest street fair as well as the oldest in Scotland; notes that Alex James is a member of the Cross-Party Group in the Scottish Parliament on the Scottish Showmen's Guild, which highlights what it sees as the importance of Scottish showmen as a contributing group to communities across Scotland; commends Alex James for his dedication to showpeople, and wishes him all the best for the future. **R**

***[S6M-07592](#) Katy Clark: Reports of Closure of Gourock Amazon Distribution Centre**—That the Parliament notes with concern the reported announcement by Amazon of the imminent closure of its distribution site in Gourock, Inverclyde, in the West Scotland region; considers that the company has been an employer in the area for 19 years, and currently employs around 300 workers; commends what it regards as the immense contribution made by these workers supporting households and providing vital supplies throughout the COVID-19 pandemic and holiday periods; notes with concern the reported allegations made by workers at Amazon warehouses in Scotland to Unite the Union's confidential whistleblowing hotline, which has allegedly included being denied basic employment rights, being refused paternity leave, being forced to stand for hours on end, and being followed by managers into bathrooms; further notes that Amnesty International has reportedly condemned Amazon for repeatedly issuing legal notices to trade union organisers who were attempting to talk to Amazon workers outside Amazon

facilities in the UK; notes reports that the Scottish Government awarded Amazon a £15 million tender to host services for a new NHS Scotland digital platform in May 2021, which, it considers, is incompatible with the Scottish Government's stated fair work approach to procurement policy; understands that a further £7.3 million has been awarded by the Scottish Government to Amazon for web services since 2018-19; notes the belief that trade union recognition should be a statutory requirement for employers seeking Scottish Government contracts; further notes the view that the Scottish Government should terminate all existing contracts with Amazon; notes calls on the Scottish Government to ensure that all staff at risk of losing their jobs at the Gourrock distribution centre are fully assisted by the company to either be relocated within the company on equivalent or superior terms and conditions, or sufficiently retrained for future employment, and further notes the view that the Scottish Government should intervene as a matter of urgency to support all affected workers, and ensure they are helped back into employment.

***S6M-07625 Russell Findlay: Glasgow Airport's Largest Ever Jobs Fair**—That the Parliament commends Glasgow Airport for hosting its largest ever jobs fair, which took place on 19 January 2023; understands that over 1,500 jobseekers attended the event, including refugees from the war in Ukraine, and some of those who are facing redundancy due to the expected closure of Amazon's depot in Gourrock; notes that 35 businesses took part, and that these included air traffic control service providers, NATS, ground handling service providers, Swissport International and Menzies Aviation, security company, ICTS, facilities management company, ABM, and catering companies, The Restaurant Group and Select Service Partners; further notes that Scottish regional airline, Loganair, was in attendance, along with many other businesses from the travel sector; understands that full-time, part-time and seasonal vacancies were available; notes the attendance of UK Government agency, Jobcentre Plus, and Invest in Renfrewshire, which is an economic development partnership between local employers and Renfrewshire Council; further notes that translators were on hand to assist Polish, Romanian and Ukrainian speakers seeking employment; praises Glasgow Airport and the businesses that made the jobs fair a success, and wishes all potential employees the best of luck in their new careers.

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
