the *International Review of Custodial Models for Women: Key Messages for Scotland* by the Scottish Government social research department in 2015, which concluded that "countries with lower rates of female prison populations tend to have different sentencing practices, including a greater use of alternatives to custody and open prisons than is currently available in Scotland"; further notes the view that Scotland's remand rates for women are too high, including in the West Scotland region; notes that the Scottish Prison Service confirmed in January 2023 that approximately 36% of women prisoners are on remand, higher than the percentage for prisoners who are men; further notes the view that the vulnerable nature of many women prisoners, offending patterns among women and the reported high percentage of women prisoners who are mothers and high percentage of women who have suffered brain injuries as a result of repeated domestic abuse, demonstrate that fewer women should be remanded into custody, and notes calls for the Scottish Government to reverse the real terms cuts to the justice budget, to fund and develop strategies to reduce the number of women on remand, and to consult with women's groups to develop sustainable alternatives to custody that reflect the specific circumstances of women.

A member seeking to introduce a Member's Bill must first lodge a draft proposal, together with a consultation document (or a statement of reasons why consultation is not considered necessary). Subsequently, the member may lodge a final proposal, in broadly similar terms to the draft, accompanied by a summary of consultation responses (or the statement of reasons). The member secures the right to introduce a Bill to give effect to the proposal if the final proposal secures, within one month, the support of at least 18 other members from at least half the political parties or groups represented in the Parliamentary Bureau, and provided no statement is made that the Scottish Government is planning equivalent legislation.
